

PARTICIPANT RELEASE OF LIABILITY
PLEASE READ BEFORE SUBMITTING

In consideration of being allowed to participate in any way in the NTX Elits fishing tournaments for the year 2024/2025 the above signed, acknowledge, appreciate and agree that:

The risk of injury from the activities involved in tournament fishing involves substantial and inherit risks, hazards, and dangers associated with outdoor activities on the water and in the wilderness, including the risk of permanent injury or death and while particular rules, equipment and personal discipline may reduce the risk, the risk of serious injury is not eliminated. I understand that these risks, hazards, and dangers include without limitation: collision with surface and subsurface water hazards, collisions with other boats; ejection from a boat while on or off plane; encounters with wildlife, animals, and insects; water hazards including drowning; injuries from fishing equipment, boating equipment, and other participants; temperature extremes, inclement weather, and unavailability of immediate medical attention in desolate areas on the lake in case of injury; dehydration; and risks associated with boating or driving a truck trailer, and boat to and from destinations.

I expressly assume all such risks of personal injury, death, and property damage, both known and unknown and assume full responsibility for my participation. I waive any claims based on negligence, gross negligence, strict liability, or breach of warranty arising from or related to my participation in NTX Elite competitions or events that I might asset on my own behalf against NTX Elite Bass series , its officers, directors, employees, and agents.

I contend that my general health is good enough to participate in this NTX Elite event or competition, and that I am not under a doctor's care for any condition that might endanger the life and health of myself or others participating in the activity.
