Agreement/Jurisdiction:

The person(s) whose signature(s) appear on this contract, known as "Client", agree that Studio 608 Janesville Name known as "Stylist", shall provide services to apply the best of her abilities, in the manner described in this document. This is a binding contract which incorporates the entire understanding of the parties, and any modifications must be in writing, signed by both parties, and physically attached to the original agreement. Client assumes responsibility for all collection costs and legal fees incurred should enforcement of this contract be broken.

Liability:

Any allergies should be reported prior to application. The Client agrees to release the Artist from liability for any complications due to allergic reactions.

Method of Cancellation/Rescheduling:

In the event of a cancelled or rescheduled event, Studio 608 Janesville requires a notification in writing 30 days prior to the original event date. If cancellation happens after the 30 day deadline the Client is responsible to pay the full amount. This is the only method of cancellation I will accept. The down payment is non-refundable in any case of cancellation.

Client Responsibilities:

It is the Clients responsibility to provide a safe and adequate working environment for the Artist. The location must include:

- Lots of natural or lamp lighting
- Enough space
- Outlets
- Table for makeup and brushes
- Enough chairs
- Insurance
- Maintaining clear communication

Payments:

A retainer fee of half of the collection amount is due at the time of booking; this payment is non-refundable and must be paid in order to secure your event day. Last half needs to be paid a week before the event day, unless otherwise agreed upon. Payments can be made with credit card, check or cash.

Travel:

A mileage fee will be charged as follows: 0-10 miles (\$80)

Photography:

Photos or videos may be taken for promotional use and advertising purposes online and printed material. Full credit will be given to any professional photos and videos taken by photographers and videographers

WEDDING DAY GUIDELINES:

- ALL CLIENTS MUST COME WITH DRY AND CLEAN HAIR. IF STYLISTS HAVE TO BLOWDRY ANY HAIR, THERE WILL BE AN ADDITIONAL SERVICE FEE.
- ALL STYLES ARE SUBJECT TO AN ADDITIONAL CHARGE BASED OFF THE COMPLEXITY AT THE DISGRESSION OF THE STYLIST.
- ALL CLIENTS RECIEVING MAKEUP APPLICATION MUST COME WITH A CLEAN FACE WITH NO MAKEUP.
- ALL CLIENTS MUST ARRIVE AT THE START TIME TO INSURE ALL SERVICES WILL BE COMPLETED BEFORE END TIME.
- IF WEDDING PARTY IS MORE THAN 10 MINUTES LATE PAST START TIME, A LATE FEE OF \$50 WILL BE CHARGED TO THE BRIDE.
- TRAVEL WEDDINGS MUST ALLOW STYLISTS ATLEAST 10 MINUTES OF SET UP TIME ON LOCATION.
