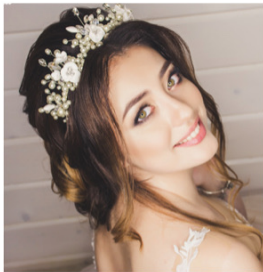

YOUR AGREEMENT:

THIS CONTRACT IS A SIGNED AGREEMENT BETWEEN CLIENT AND STUDIO 608.

- CLIENT IS RESPONSIBLE FOR COMPENSATION OF STYLISTS IF "NUMBER OF SERVICES" ARE CHANGED AFTER CONTRACT IS ORIGINALLY SIGNED.
- IF EVENT IS CANCELLED OR RESCHEDULED 30 DAYS PRIOR TO ORIGINAL EVENT DATE, CLIENT IS RESPONSIBLE TO PAY THE FULL AMOUNT.
- DOWN PAYMENT TO RESERVE DATE IS \$100 AND IS NONREFUNDABLE.

TRAVEL FEE

- \$80 FOR WEDDINGS UNDER 10 MILES FROM STUDIO 608 WEDDING FURTHER THAN 10 MILES ARE SUBJECT TO ADDITIONAL TRAVEL FEE CHARGE.

LIABILITY:

- ANY ALLERGIES SHOULD BE REPORTED PRIOR TO EVENT. IF ANY ALLERGIC REACTIONS OCCUR, STUDIO 608 IS NOT LIABLE.

WEDDING DAY GUIDELINES:

- ALL CLIENTS MUST COME WITH DRY AND CLEAN HAIR. IF STYLISTS HAVE TO BLOWDRY ANY HAIR, THERE WILL BE AN ADDITIONAL SERVICE FEE.
- ALL STYLES ARE SUBJECT TO AN ADDITIONAL CHARGE BASED OFF THE COMPLEXITY AT THE DISGRESSION OF THE STYLIST.
- ALL CLIENTS RECIEVING MAKEUP APPLICATION MUST COME WITH A CLEAN FACE WITH NO MAKEUP.
- ALL CLIENTS MUST ARRIVE AT THE START TIME TO INSURE ALL SERVICES WILL BE COMPLETED BEFORE END TIME.
- IF WEDDING PARTY IS MORE THAN 10 MINUTES LATE PAST START TIME, A LATE FEE OF \$50 WILL BE CHARGED TO THE BRIDE.
- TRAVEL WEDDINGS MUST ALLOW STYLISTS ATLEAST 10 MINUTES OF SET UP TIME ON LOCATION.

STUDIO 608 ACCEPTS CARD OR CASHI AS A FORM OF PAYMENT.

- WEDDING PARTIES 6 PEOPLE AND OVER, ARE SUBJECT TO A 20% GRATUITY CHARGE FOR EACH SERVICE PROVIDED BY STUDIO 608.
