

Below I would like to provide some highlights on some our 2023 Strategic, Financial and operating activities.

Strategic Highlights

- Enhancement of Community Policing through assigning Deputies to districts throughout the County and to be present in our area schools by attending activities and engaging students in a positive manner.
- Re-established Law Enforcement Partnership with Worth Township with the assignment of a full-time Deputy as well as providing additional hours during the busy summer months.
- Hosting of County Wide training in the area of Response to Active Violence situations.
- Conducting Joint training with our special response groups and local police, fire and EMS responders.
- Enhancement of Dive/Rescue services through joining the Southeast Michigan Dive Group.
- Enhanced partnership with area counties to combat Human Trafficking

Financial Highlights

- Successful negotiation with the U.S. Marshals to increase the daily Federal Bed Rental revenue by housing Federal Inmates.
- Over \$354,150.00 in successful grant funding obtained to fund 416 Secondary Roads, Marine Patrol
 purchase a Jail Body Scanner, update incompatible handheld radios, bullet proof vests, emergency
 response ARGO and Trailer, new firearms systems and more.

Operating Highlights

- Successful collaboration in working with the County Board of Commissioners to fix growth rate in employee wage scales to better help with Recruitment and Retention of our Uniform Services and Corrections Staff
- Implementation of "The Sheriff App" to better serve and push out information to our residents
- Hosting Community Events such as the screening of "It's Happening Right Here" to bring community awareness regarding Human Trafficking.





Bed Rental Program Revenue

The Sheriff's Office has a long history of renting jail beds to outside agencies to include the United States Marshals Service, since 2002. In April, 2013 we opened the jail addition that was built onto our existing facility. Since the addition opening, the County has seen an increase in bed rental revenues of over 1 Million dollars per year. Since the 1990 bed rental started, the Sheriff's Office has brought in over 43 Million dollars in revenue. In 2023, the Sheriff's Office brought in \$2,782,776.00 in Bed Rental Revenue.

UNIFORM SERVICES DIVISION

The Uniform Services Division's primary responsibility is to provide the highest quality of law enforcement services to Sanilac County citizens and visitors.



About

The Uniform Services Division is comprised of one (1) Lieutenant, six (6) Sergeants, fifteen (15) Deputy Sheriff's and three (3) Records Clerks. Our office provides 24 hours a day/7 day a week law enforcement services to the community, responding to over 13,900 calls for service in 2023 alone. Specialized Units: Detective Bureau, Traffic Crash Investigation, Traffic Enforcement, K-9, Marine Patrol, Drug Task Force. Our Office is also comprised of many dedicated community volunteers which help support our Dive/Rescue Team, AERO Unit, Sheriff's Posse, Victim Services Unit and Search & Rescue.






Work Crew Program

The Sanilac County Sheriff's Office Inmate Work Crew Program has been an effective service-oriented program. The Work Crew has donated countless hours assisting the local communities to include the following:

Critter Crew Program

Throughout the year, the Sanilac County Sheriff's Office Inmate Work Crew conducts what we call "Critter Control." The Work Crew effects entail traveling throughout the County, picking up deceased animals (Deer, Skunk, Racoons, etc.) from the thousands of miles of roads within our 964 square mile county.

In 2023, our "Critter Crew" picked up approximately 314 deceased animals.
