# **JOB POSTING**

**Position:** Marine Deputy (Seasonal: May-September)

**Rate of Pay:** \$16.35 a/hr.

**Hours:** Typically Thursday-Sunday, as needed or scheduled

**Reports To:** Sergeant assigned as Marine Division Supervisor

Lieutenant – Uniform Services Division

**Open To:** All Qualified Applicants

The Sanilac County Sheriff's Office is currently accepting applications for part-time seasonal Marine Deputy(s). Starting wage for the position is \$16.35 a/hr.

Applicants being considered for employment will be required to pass a criminal background check, a psychological test and a health examination, including a drug screen. Applicants will also be required to complete a personal history questionnaire. This is a sworn position and applicants may be required to carry a firearm in the course of their duties.

#### **General Job Summary:**

To lawfully enforce the Marine Safety Act on local waterways. To lawfully enforce local water related ordinances. To lawfully enforce those law enforcement powers as granted by the Sheriff of Sanilac County. To provide boating safety and education. Patrol Sanilac County waterways to include Lake Huron area of responsibility, conduct vessel safety inspections, respond to calls for assistance, issue citations, investigate accidents, remove hazards, Maintain Marine Division equipment, To perform related work as required.

#### **Education:**

High School Diploma/GED

#### **Qualifications/Skills Required:**

- Must be at least 18 years old.
- Good physical condition; pre-employment MCOLES physical and agility testing may be required.
- Reasonable knowledge of local waterways.
- Ability to prepare accurate written records and reports.
- Ability to react quickly and positively in emergencies.
- Ability to swim and life save; swim test may be required,
- Ability to work effectively with other employees and the general public.
- Valid Michigan Driver's License
- Experience in operation and/or knowledge of watercraft is helpful swim test may be required at a later date
- background investigation prior to employment.
- Successful completion of Boaters Safety Course
- Successful completion of Michigan Sheriff's Marine Safety Training Academy; may be required.
- Includes working weekends and holidays.
- This is a Non-benefited position.

#### **ADDITIONAL REQUIREMENTS:**

- Upon reaching the age of 21 years old a non-MCOLES licensed employee must obtain their Concealed Pistol License (CPL).
- Employees hired with no prior law enforcement experience will not carry a firearm for their first year of employment unless otherwise authorized by the Sheriff. (Military Law Enforcement does count towards law enforcement experience)Less Lethal options such as Taser/pepper spray carry will be allowed upon successful completion of the Department's Taser/pepper spray Training and certification program.
