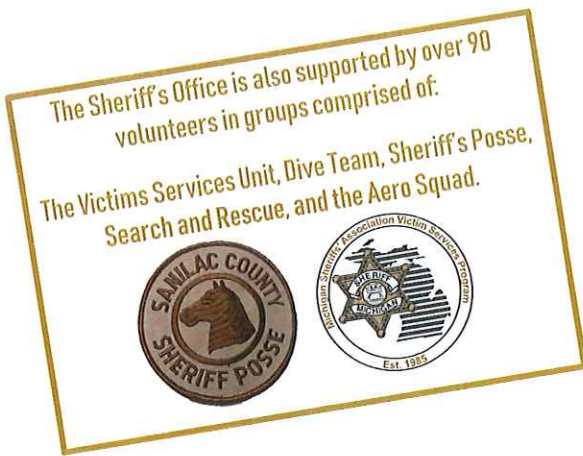

Organizational Structure

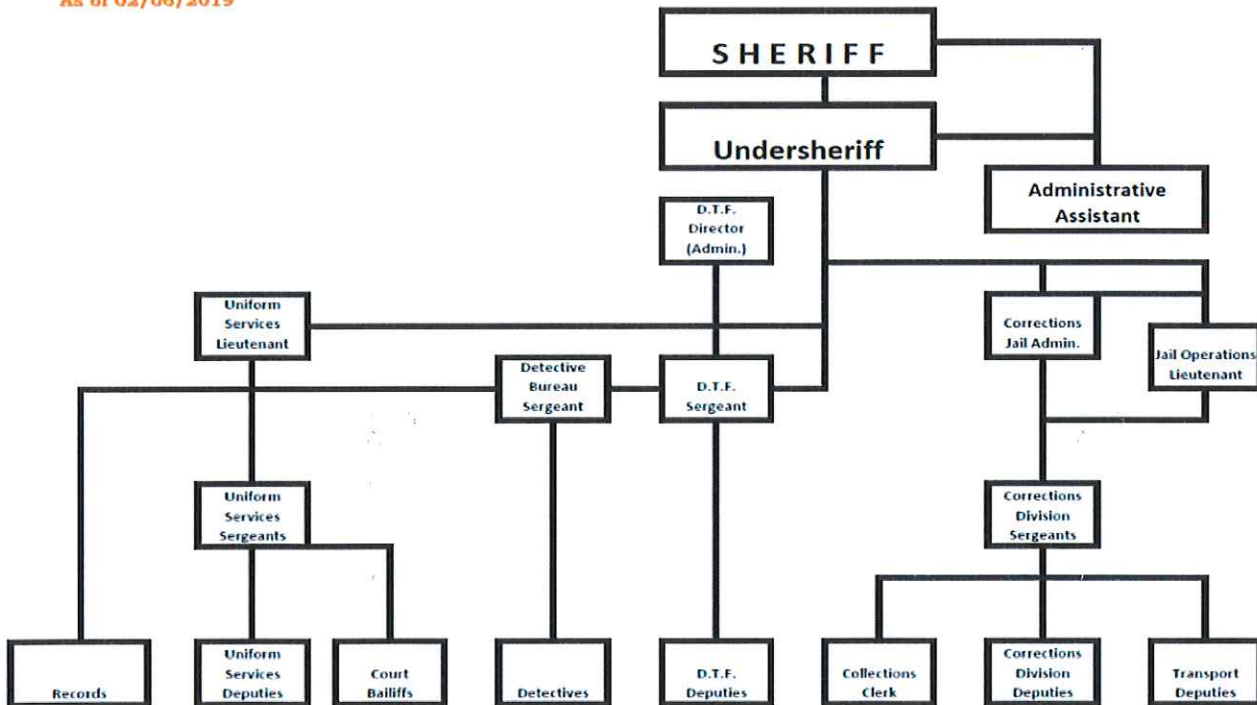

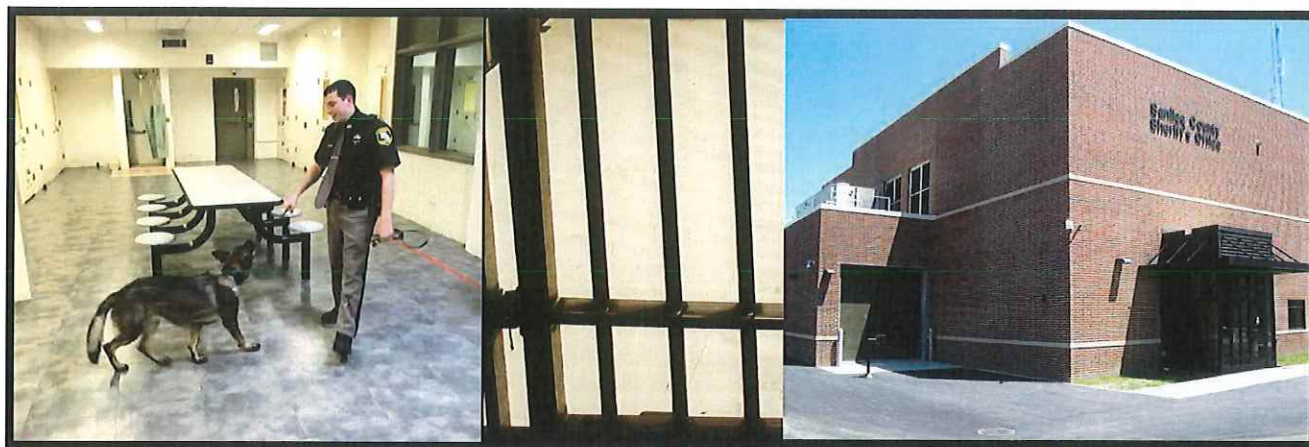

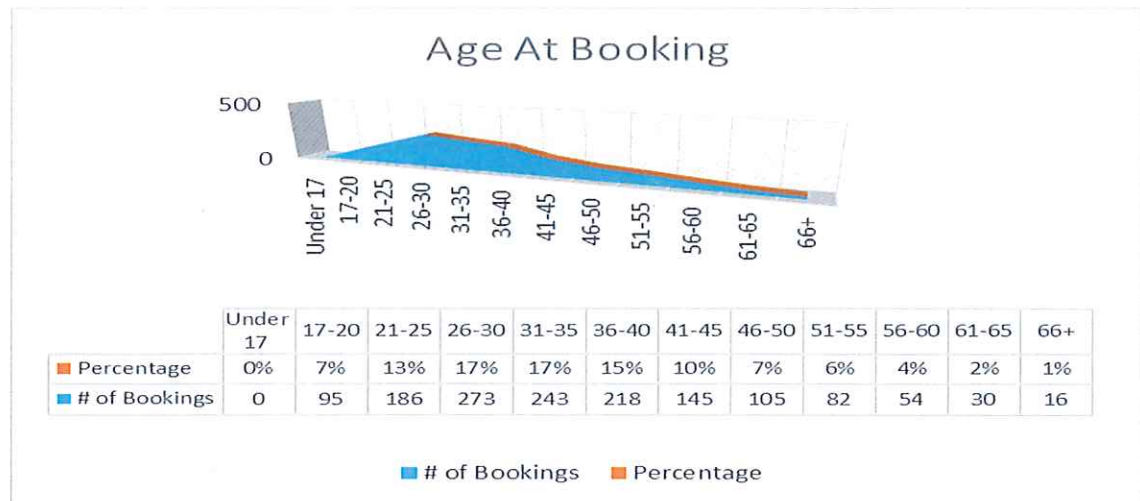
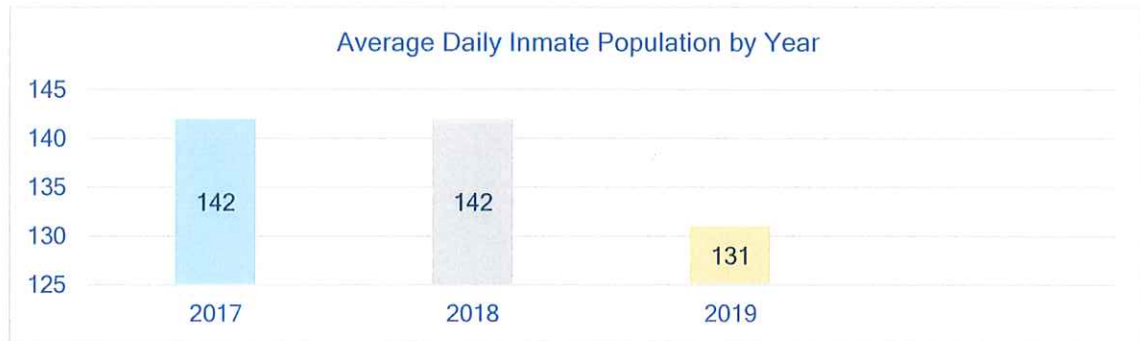
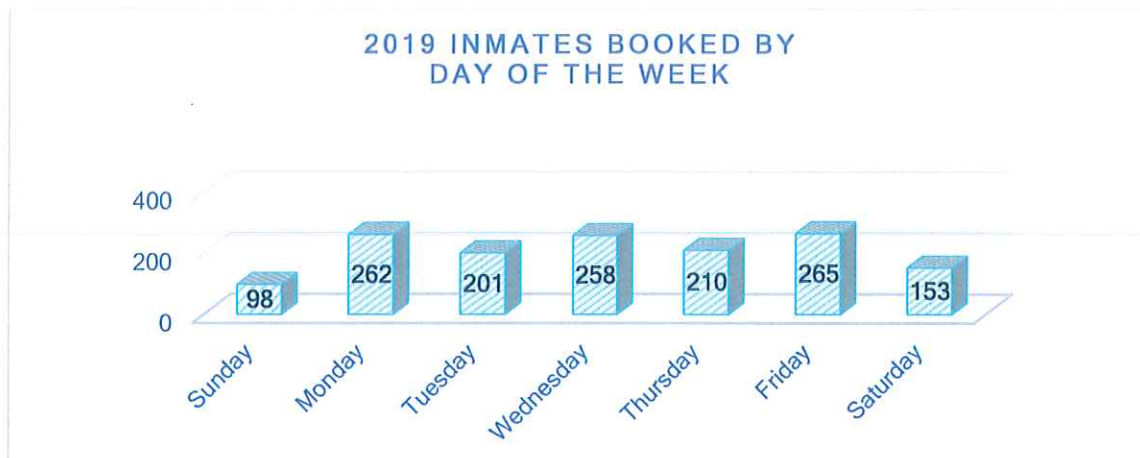
REVENUE FROM JAIL BED RENTALS

Starting back in 1990 the Sheriff's Office started a bed rental program to help supplement County revenues. In 2002 the bed rental program expanded by renting beds to the United States Marshals Service which led to a dramatic increase of revenues of over \$1.5 million dollars a year. In July of 2013, with the newly constructed jail addition attached to the existing facility opened. Since its completion, the County has seen additional annual rental revenues of over 1 million dollars, and a yearly average of \$2.7 million dollars. Overall, the program has brought in nearly 33 million dollars in revenue since its inception. \$23 million dollars since being elected your Sheriff.



*Every bed used by Sanilac County is a reduction of approximately \$31,750.00 per bed annually

Number of Inmates Booked into the Sanilac County Jail



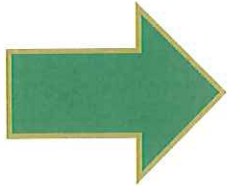
Work Crew Program

The Sanilac County Sheriff's Office Inmate Work Crew Program has been a productive service-oriented program. The Sanilac County Work Crew has donated countless hours assisting the local communities including, but not limited to the following:

Throughout the year, the Sanilac County Sheriff's Office Inmate Work Crew conducts what we call "Critter Control." Efforts by the Work Crew entail traveling throughout the county picking up deceased animals (deer, skunk, raccoons, etc.) from the county and state roadways.

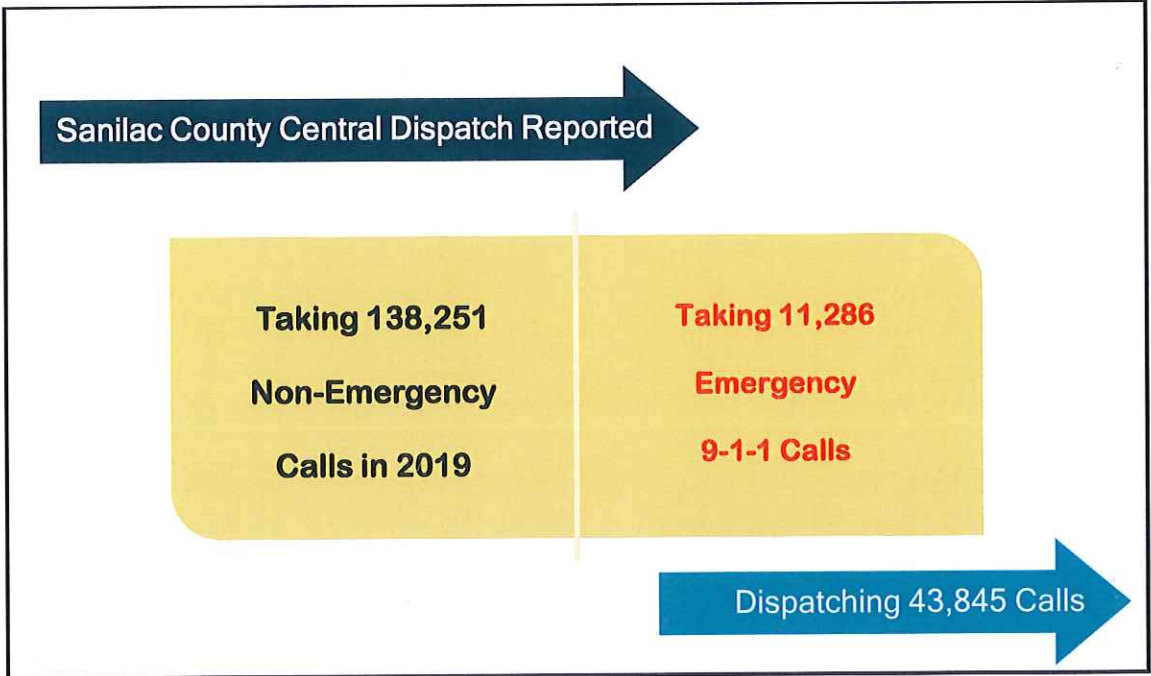
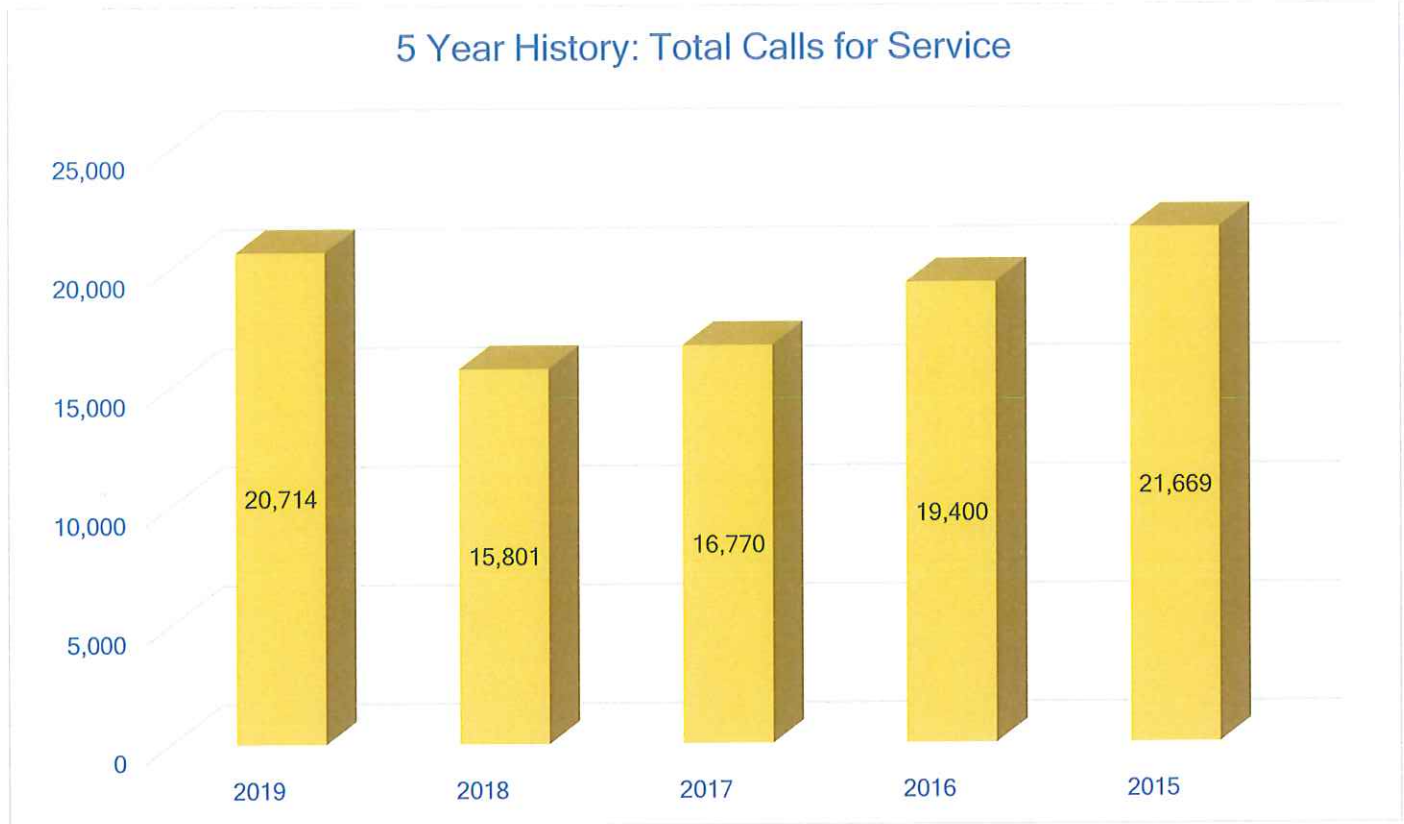

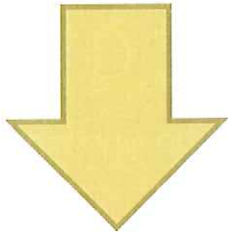
Calls for Service

CRIME PREVENTION TIPS FOR BURGLARY

The Sanilac County Sheriff's Office needs your help in preventing home Burglaries. Burglary violates the safety and security of the home. Many burglaries can be prevented if you follow these tips:

- Never leave your door unlocked or open – use dead bolt locks, they are a great deterrent to burglars.
- When you go out, close and lock your windows. Many burglars enter homes and apartments through open windows. Windows on or near fire escapes should always be locked. Safety gates on fire escape windows are a good investment.
- In apartment buildings, don't buzz strangers in. Anytime you see a suspicious person near your home, call the police.
- Don't permit unexpected utility workers, deliverymen, or strangers into your home. Ask them for their I.D. and phone number to their office. Call 911 if you are not sure of their identity.
- Make sure lobby and vestibule doors close and lock; notify the building owner or management if they do not.
- Apartment dwellers – insist that the building management improve security e.g. better locks, better lighting, locked lobby doors, security cameras, etc.
- Burglar alarms are a good deterrent.
- Give your home or apartment an "occupied look." Lights or a radio on automatic timers may deter burglars. Bright motion activated lights are a good deterrent as well.
- Open garages and sheds are easy targets for burglars.
- Trim shrubs and branches away from doors and windows for better visibility.



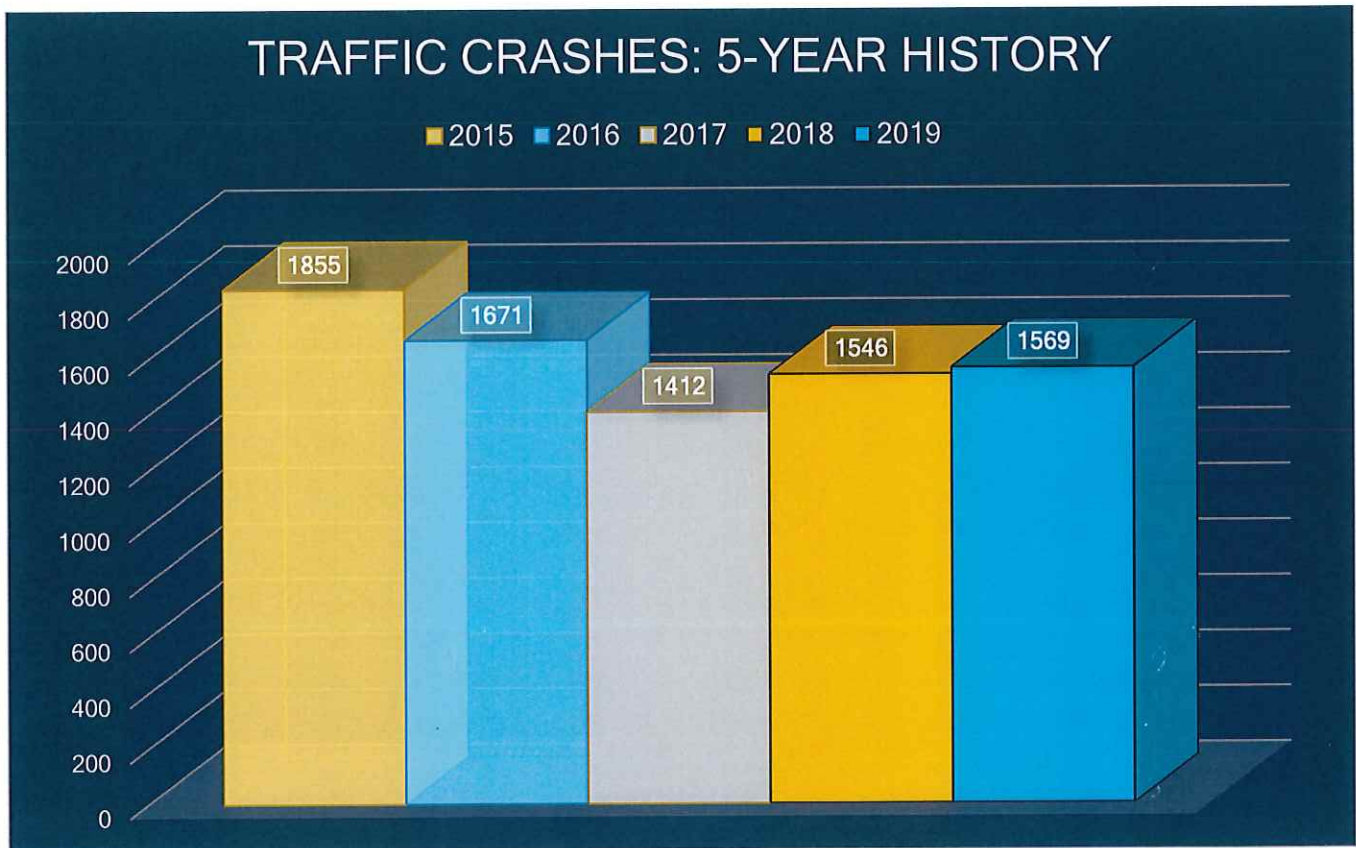

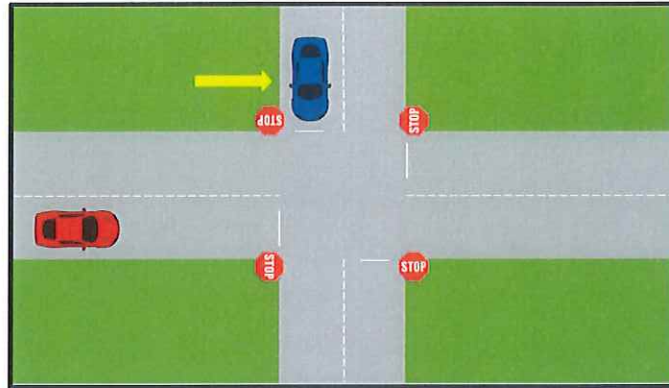
