Contributions made to the West End Family Link Center (WEFLC) Community Facility enterprise zone project will help to fund the remodel of an existing building, land purchase and new building development for a Community Facility to provide resources not presently available in the rural area and support the operations of new and existing programs. Your support in this will also allow you to receive a substantial benefit: up to a 25% tax credit above and beyond the existing charitable tax deductions through the State of Colorado and the Federal Government. This tax credit applies to all Colorado taxpayers, whether you itemize or not.

The new facility will be more than double the size of the current site, enabling the expansion and development of new training programs and improving service delivery.
