

I NOW THIS INDENTURE WITNESSETH AS UNDER:-

- 1), That in order to give effect to the aforesaid desire, the Settler/Founder have set apart and handed over to the Trustee as sum of Rs.5000/- as Trust Fund which expressions shall include cash, include any other property or investments of any kind whatsoever into which the same or any part to be spend for the fulfillment of aims and objects of the Trust.
- 2). Name of the Trust "HAMARI PAHCHAN"
- Registered office of the Trust: 15/6 CHHOTI SUBZI MANDI JANAKPURI NEW DELHI-110058.

Which may be changed from time to time to such other place or places as the trustees may deem fit and proper at their discretion.

4). THAT THE AIM AND OBJECTS OF THE TRUST ARE AS UNDER:-

- To work with communities and the government health system to reduce
 preventable deaths, fight under-nutrition, improve new born and maternal health-care.
 We improve access to basic health care facilities, impart health education, ensure
 immunization advocate for the implementation of the Integrated Child Development
 Scheme.
- To work closely with authorities to help prevent children from being exploited. We prevent them from being trafficked into commercial sex, exploitation and child labour. We instigate measures to withdraw child domestic workers as domestic help and enroll them in schools.
- 3. To work towards developing education policies, refining vocational skills and advocating for access to school for all the children. Other aspects include tackling poverty, imparting quality education, training teachers and helping communities to run schools. Thus we work towards the creation of quality and inclusive education for all children.
- 4. To respond immediately to the affected families with food aid, water and essential items and also report long term recovery process for such families. We work to ensure that children and their families are better prepared to cope with emergencies.

- To establish and continue the management and administration of the Hamari Pahchan towards fulfilling the above aims
- 6. To establish, develop, maintain and /or grant aid in cash or in any kind to run hospitals, medical, school, medical dispensaries. Educational Institutions, Colleges, Maternity Homes, Children and Women Welfare Centers and or such other similar charitable Institution in India for the benefit and use of the general public for common welfare.
- 7. 'To establish ,run, support and grant aid or their financial assistance to school ,libraries, reading rooms, universities, Laboratories, Research Centers, Clinics,& other Institutions of the like nature in India for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the common people.
- 8. To establish, maintain or grant aid for the establishment and/or maintenance of historical parks, garden, Rest Houses, Historical Monuments, Buildings for the promotion of science, Art, Literature, Music ,Drama and Fine Art and other Institutions in India having similar objects for the benefit or the public in general.
- 9. To grant aid or render assistance to other public charitable Trust of Institutions.
- To give stipends, scholarship and monetary aids to the poor and needy students and scholars.
- 11. To advance loans to deserving students for pursuing their studies on reasonable rates of interests to be repaid by students in convenient installments or in any other manner as may be decided by the settler or the Managing Trustee from time to time.
- 12. To open found and maintain or contribute to the opening and maintaining of such Institution where work on living wages can be provided to poor and middle classes people and as may be conductive to the development of such industries in any part of India Union for the benefit for the poor.
- 13. To open found establish or finance, assist and contribute for the maintenance of sanitarium asylums, hospitals, Mobile dispensaries, maternity homes and any other Institutions for treatment of diseased and disorders of the human bodies.

- 14. To open found, establish, maintain and assist asylums for lepers of those sufferings from contagious diseases and also institutions for the relief of the destitute or disabled persons
- 15. To construct, build and maintain Dharamsalas, saraies, Hostels, Night Shelter for public use or benefits and shall not involve the carrying of any activities of for profit.
- 16. To establish, maintain, run and supervise Barat Ghar, Community Centers Clubs/Sports clubs /vayamsalas etc. For the use of the common people to provide them benefits.
- To open found establish or contribute for the maintenance of blinds, orphanages, widows homes, lunatic asylums, poor houses etc.
- 18. To distribute foods, blankets, rags, quilts and all kinds of cotton or woolen clothing's to the poor and needy people.
- 19. To help in cash or in any kind to the Indian Military Personal and their families who, from time to time, make scarifies become disabled and lay their lives for the cause of the Nation.
- 20. To set up instructional or training Centers for imparting instructions and training in medicine, banking commerce, Social services, village construction works, small scale industries and such other subjects as may be determined from time to time.
- 21. To give awards, certificates and assistance in cash or any kind in recognition of Meritorious work done in the fields of education medical, research and relief, social welfare, development of Khadi and village cottage Industries, relief to the poor and the advancement of any other objects of public utility and/or renders Services to the physically handicapped persons, orphans, and/or Welfare and benefit of the people in rural and weaker sections of the societies.
- 22. To encourage the people for eye donation and to arrange for blood donation camp for the welfare of the poor needy and common people.
- 23. To arrange for vocational training to the poor widows helpless persons such as to the SC/ST/OBC candidates as well as physically handicapped persons providing training courses in Type-writing Short hand writing Computer Operating, stitching Tailoring Cutting, weaving, Knitting woolen dresses and other related training courses in different streams to become them self-employed.
- 24. To promote, establish and develop medical research Centers for different systems for the development and advancement of Medical facilities and relief of the, patients of our county.

- 26. To apply and get land/building/premises by purchase or by receiving donations from the Governing Authority or from the Public to fulfill the aims and objectives of the Trust. And generally to do all the other acts, deeds and things which are (not specially mentioned hereinabove but related to progress of the Trust.
- 27. To establish and manage Social and Spiritual worship place and functions for the benefit of devotees, pilgrims, tourists and students going on educational courses.
- 28. To set up printing press for publishing and distributing text and note books, study materials to parsons interested in studying Yoga, vadas and philosophical books of the like nature and study material for the students and those who are attending competition examinations.
- 29. To grant and manage centers for training of youths in self-employment and joboriented courses and set up Gymnastic/Health Centers for physical exercises to keep the fitness of body and mind of general public.
- 30. To conduct Bhandaras and Langars regularly for the poor needy persons.
- To provide free water and other facilities to the poor and weaker sections of the societies.
- 32. To barrow, raise loans from any persons, bank, or financial Institutions in such manner as the Trustees shall think proper or convenient for furtherance of objects of the Trust and for this purpose the Trustees may secure repayments of these loa in any manner, as may be decided from time to time..
- 33. To do all necessary things for and incidental for the attainment of above objective of the Trust, for common welfare.
- 34. The Trustees shall be entitled and be at liberty to accept gift, voluntary contributions from any person, firm or concern Institutions or Government, and t(collect subscript one, donations or aid from State Government, Central Government to augment the Trust & fund and use such money for fulfillment of t aims and objects of the Trust.
- 35. To organize seminars on social justice, economically enlistment, to raise demand for legal rights and privileges for the SC/ST/OBC, Minority Community and other people who belong to back ward classes.
- 36. At the time of death of any poor persons the crimination expenses will be boned by this Trust.
- 37. To arrange collective marriages of poor girls and boys.

for

- 38. To help and assist the poor families of any caste, color, creed or as well as any religions.
- 39. To apply and get land/building by purchasing or by receiving the same by donation/gift/contribution from the Government concern of the aims and objective of the Trust.

RULES AND REGULATION OF THE TRUST: -

The income and /or corpus of the fund of the Trust will be utilized from time to time for the benefit of the beneficiaries of the trust as per the objects and aims of one or more of them as the trustees may decide with the consent and approval of the Settler/founder

POWER OF THE SETTLER/FOUNDER:-

- 1. The Settler/ founder of the trust shall continue to act as trustee till his life time. he may however in his discretion appoint one or more other persons as he may deem fit, He may in his discretion withdraw such power so vested by him in any trustee. He may also appoint constituted of one or more persons for carrying out one or more objects of the Trust. He may dismiss any such Trustee or committee or reconstitute the same as he may think proper in his personal discretion.
- 2) During the life time of Founder/Settler he can appoint his nominee and after his death the appointed nominee and in case none is appointed then the legal heir will enjoy all the rights of founder as presently the founder is enjoying. This process of nomination or successors shall continue till the working of the trust repeat the Settler of the nominees(s) shall continue to hold all those power at present enjoyed by the Settler.
- 3) The Settler/founder shall have the power to cast two votes in the case of the or in difference opinions, decisions understanding or any disputes arise amongst the Trustees regarding any issue on behalf of the Trust.

POWER OF THE MANAGING TRUSTEE:-

- The managing trustee may remove any Trustee/Trustees, if the work of the any
 Trustee is not satisfactory and /or against the public policy without prior intimation
 of the said Trustee. But with full consent and approval of the Settler/Founder.
- The managing Trustee shall have right to serve the trust by fulfilling the aims and objects of the Trust on behalf of the Settler/ Founder and in favor of the beneficiary as per aims and objectives and rules and regulation of the Trust.
- 3. The managing Trustee has full responsibilities to manage, control look after the Trust and its activities with the help and assistance of other trustees as per terms and conditions of the Trust Deed with full consent of the Settler/Founder. And in the absence of the founder/Settler the Managing Trustee has right to take financial decision regarding any issues of the Trust.

4. That if the Managing Trustee violates or denies the duties and do unlawful acts which is beyond of the rules of the Trust, then he will be fully liable for all costs, damages. Losses for the same.

POWER AND DUTIES OF THE TRUSTEES:-

- In the absence of the Managing Trustee, the trustees will serve the Trust as per direction of the Sattler/Founder and the terms and conditions of the Trust.
- The Trustees will follow all the terms and condition of the Trust and they will save the Trust accordingly.
- The board of Trustees shall have the following powers appropriate and necessary for the fulfillment of the any or all of the aims and objectives of the Trust for the affective and efficient administration of the Trust matter and affairs.
- To keep and maintain accurate account of the income and expenditure of the Trust regularly.
- At the and of every financial year the 1st April the 1st day of March of every year's to get the account audited arrangement would be done by the trustees.
- To accept donation, contributions, subscriptions, gifts and/or other grant in aid either in money or by cheques etc. payable in favour of the trust from the people of India and abroad.
- To enter into any contracts and borrow money for the purposes of the trust and management of its properties and assets.
- To amalgam the trust with other Institution, association Trust or organization having public charitable and secular objects and purposes with the other trustees and the settler/founder consent as well with the consent of the managing trustee.

To appoint, nominate and other person and to give such other designation to various person extending help for the running or for the cause of the trust with the consent of the senior and the managing trustee

The office of the trustee shall when become vacant on the happen ding of any of the following events:-

- A. Death of Trustee.
- B. Physical or mental inefficiency of a trustee.
- C. Resignation of the Trustee.
- D. On being rendered incapable to perform the duties of the trust.

- E. In being revisited of any serious criminal offence involving moral turpitude.
- F. On being adjusted insolvent.

TRUST FUND :-

The trustees shall irrevocable hold and stand, possessed of the said cash sum of Rs.5000/-(hereinafter called the trust fund), which expressions shall include the conversion thereof and/or investment for the time being of the same and/or accumulation addition and accretions thereto and dividends income and/or interests income or any other income or any other income of the said trust fund upon the trust and with and subject to the powers and provisions wherein declared and contained of the concerning the same.

- A). Investment of its funds.
- B). Contribution received from time to time.
- C). Such activities which the trustee may agree to carry on in the course of the actual carrying out of then purposes of the trust. Otherwise earned by the trust by not defacing the purposes if any way.

SOURCE OF INCOME:-

The settler or the trustees may accept donations, contributions, subscription or gifts from any person or persons or their trusts Institutions, state and central government or any country and in any other form including money or in kind or any right or property moveable or immoveable buildings, lands raw materials, finished or fabricated goods, running concerns, machinery stores, ornaments, billions, royalties shares in public or private factories, and workshops situated in any part of the world or useful animals, such as cow, horses etc. in good conditions provided how every that the settler or the trustee may decline to accept the any such donations or the trustees may decline to accept the any such donations, that or contributions etc. at their discretion.

BANK ACCOUNT :-

All the incomes of the trust in cash should be deposited in any Nationalized Bank in account in the name of the trust operated by the settler or managing trustee with any one of the trustee. And the managing trustee may keep rs.5000/- with him to expenses in emergency period.

All the main account books of the trust shall be kept at the head office of the trust. And the branch offices of the trust wherever establish to be maintained separate account of their own as desired by the settler which would be adjusted with the head office account and when considered proper and convenient.

OTHER TERMS:-

- The settler or the trustees may appoint one or more officials of staff to manage and administer the trust and maintain the books of accounts of the income and expenditures etc. of the trust and to carry out correspondence and all other business, on behalf of the trust and other servants as may be necessary and their remuneration may be paid out of the trust income.
- 2. The settler or the trustee may also, in the conduct of the trust employ and pay such agent or agents, and other employees salary or commission, as they may at their description consider necessary and delegate or to cover upon him or them such authority and power in connection with the trust hereof as the settler or the trustees may deem expedient proper.
- 3. The settler or the trustees shall have the power to sell all kind of assets and properties of the trust or any part thereof, or exchange the same for equality or exchange and apply the money to arise from any such sale or to be received from equality of exchange as aforesaid for adding to the general funds, of the trust or for the purchase of any business or land or trade or buildings on for affections alterations or improvements or for repairs other than sundry repairs, or for any other purposes or which the trust property as such i.e. the corpuses may be applied of utilized.
- 4. That the settler or the trustees may lease of setout on rent or realty and land, buildings, property, Industry, machinery, factory, etc. belonging to trust or acquired or constructed for the purposes of the trust or any part thereof, or any land, building or other property vested in it, which may not be for the time being recoiled for the purposes of the trust, to any person or persons, either from year to year or for a terms of years, at such rent and subject to such conditions and concerned as their may think fit and proper and the rent or realty to be received shall from part of the income of the trust property and be applicable accordingly.
- The settler or the trustees shall hold every year an annual meeting. It shall ordinarily be held in the month of January, the trustee or the trustees may from time to time, hold ordinary meeting for the transactions of day to day or any special business.
- At the annual meeting in each year report of previous year will be read, accounts
 will be approved budget for the coming year prepared and sanctioned and
 election of office bearers held.
- 7. In case the number of trustees are move than three one third of the number or the trustee shall form quorum for an ordinary general meeting and for any annual meeting for election of office bearers of trustees or passing budget, at least two third of the existing trustees shall from the quorum.

- 8. The settler or the trustees shall have the power to institute, conduct, defend, compound or abandon any legal proceedings by or against, the trust its officers of otherwise concerned the affairs of the trust and also to satisfaction of any debts due do or any claims or demands by or against the trust to arbitration and to observe and perform the awards, to engage counsel, advocate, lawyers to appoint attorney, to execute in their favour the vakalat namas or powers or attorney to appoint permanent legal adviser to the trust or such representative as may be agreed, to appoint or dismiss managers, secretaries , servants and necessary staff, to open any bank account and withdraw moneys there from, to grant receipts, release of other discharges for money due or payable to the trust.
- 9. The settler or the trustees may delegate any power to any or more trustees, by a resolution of the trustees to the effect, to act jointly or severally, with powers to transfer, sub-delegate his or their powers to any body whom they consider fit for that purposes by means of power of attorney or attorneys executed for that purposes or by letter or letters.
- 10. The Trustees shall not be entitled to any remuneration but they may be paid all reasonable travelling and other expense incurred for attending meeting of the trustees or in connection with the business of the trust provided however that the trustees may be paid such honorarium for special service to the trust such in management of any business, as may be decided upon the settler or the trustees from time to time.
- 11. The quorum for meeting of the settler of the trustees shall be 2/3rd The decision of the majority in case of difference of opinion among the trustees shall be final. The chairman in a matter of the will have a casting vote.
- 12. Any resolution passed by a majority of the trustees, on circulation to all the trustees, shall be as good as passed in meeting of the trustees.
- 13. Any trustee shall have to hold office and be removed from his trusteeship on the happening of any one of the following events:
 - a) Death of the trustee.
 - b) Insanity of the trustee.
 - c) Resignation of the trustee.
 - d) On his/her becoming an undercharged insolvent.
 - e) On his being convicted of any office involving moral turpitude. But such personal disqualification will not debar the heirs or other members of his family being or becoming a trustee.
- 14. A trustee other than the settler may be recovered by writing, signed by all the remaining trustees, without assigning any reasons therefore.

- 15. The settler or the trustees may at any time if so considered necessary of beneficial to the trust rates or borrow money with or without security, or by mortgaging he property of the trust or by the guarantee of the trustee of others for the use and benefit of the trust as they may consider proper.
- 16. That the funds of the trust shall be invested in the make specified under the provisions of the income tax act 1961 or subsequent amendments from time to time.
- 17. That in the event of dissolution or winding upon of the trust the assets remaining as on the date or dissolution or winding up of the trust, shall under no circumstances by distributed amongst the trustee/members of the governing body, but the same shall be transferred to another charitable trust, society, association or institution whose objects are similar to those of this trust which enjoys recognition under section 80-G, of the income tax act of 1961.
- 18. In the aforesaid execution of the trust and powers hereof no trustee shall be liable for any loss to the trust property arising by reason of any investment made in good faith or the negligence or fraud of any agent employed by him or by any other trustee there, of all though the employment of such agent was not strictly necessary or expediting or by reason of any mistake or omission made in good faith by any trustee hereof, or by reasons of any other matter or things, except willful individual fraud or wrong doing on the part of the trustee who is sought to be made liable.

NOTING:-

Contained in this deed shall be deemed to authorize the trustee to do any act, which may in any way, be constructed as violation for country of the provisions of section 2(1), 12, 12-A,13 and/or 80-G, of the income tax act 1961 or any statutory modification thereof and all activities shall be carried out without a view to benefit the public at a large, without any profit motive and in accordance with the provisions of the income tax act, 1961 or any statutory modification thereof

That in the event of dissolution of the Trust if there remains a surplus or property after satisfaction of its debts and liabilities, whatsoever not impress with any trustee, the same shall not be paid or distributed among the trustees of the Trust or any of them but shall be given to some other trust or Institution working fort the same or similar object as those of the Trust.
