

2020 National

- Stephanie publishes the Massage Therapist Return to Work Campaign. This campaign helped employees communicate their needs and expectations to their employers when returning to work after the Covid-19 shut-down.
- Stephanie publishes local, state (Arizona), and National resources for massage therapists regarding Covid-19 safety, and resources to find assistance with their basic needs.





2020 Arizona

- Stephanie publishes local and state resources for massage therapists regarding Covid-19 safety, and resources to find assistance with their basic needs.
- Stephanie intervenes with a major employer in Arizona (9 locations) to get monies owed for an employee in Arizona who had pay withheld for services rendered and wins.





2020 California

- Stephanie worked with massage therapists in California to find an attorney to discuss a class-action lawsuit against one of the largest employers in the state for breaking Covid-19 mandated policy and violating their employment contract by forcing them to perform massage therapy outdoors during fire season.
- Stephanie worked with a group of massage therapists in Santa Clara County, California to petition the government to reopen massage therapy in their county after the FSMTB published Covid-19 work-related guidelines and won.





2020 Georgia

- Stephanie worked with massage therapists in Georgia to advocate to remain closed during the early Covid-19 emergency, before there were any guidelines on how to practice with the disease.
- After Georgia massage therapists returned to work with no guidance on how to practice with the disease, Stephanie assisted several massage therapists with reporting business violations of state mandated Covid-19 policies.
- Stephanie participated in union organizing conversations with Georgia massage therapists working at a franchise.


2022 Organizational Impact


2023 Organizational Impact
