Classic Car, Truck, Tractor & Motorcycle Show June 1, 2025



THE DOWNSIDE OF A SLOOOOOOOOOW ELECTION

On April 1st, Big Rock (and Kane county and the state of Illinois) will have our only election for 2025. We will be electing members to the Village Board, the Township board (including a new Supervisor), the Park board, the Hinckley-Big Rock School board (plus regional boards), and voting on at least one referendum. With all that, and with such direct impact on our taxes and communities, this will be another riveting election day like last November, right?

Probably not. There are no uncontested elections this time around. Even two positions with no one running at all. Other than Kane County's sales tax referendum question,



seeking to impose a more than 10% permanent increase, there isn't much that isn't already decided. Although there could be write-in candidates just to spice things up. Sure, Big Rock will vote more than the rest of the county. We always do. Just seems unlikely to reach the turnout from last year.

Looking ahead to 2026, we are in dire need of new election judges, especially Democrats. The county is legally required to balance the number of judges as best they can, but for many years we've been very low on one party. One vital step in the election process is the two-party verification of registration, and for that requirement it is vital we have more Democrats on election day. Without more local judges, people who would know the community, the county will be forced to send in outside judges to maintain their legally required levels by party.

Yes, it is a long day, and while it is paid, the money isn't a huge amount. But having free and fair elections requires work and commitment from more than just the elected officials. Plus, we do have some great meals and snacks throughout the day!

And, yes, some high school students CAN serve as election judges. If interested, please check with your school administrators for options and requirements.

Kane County Tax Referendum

April 1 is also your opportunity to vote on a county-wide referendum on the ballot. The referendum asks whether to establish an additional 0.75% sales tax within Kane County. The proposed county-wide tax would add 75 cents per \$100 spent on all applicable retail sales, with exemptions for certain essential items such as groceries and prescription medications.

Kane County currently does not levy a sales tax. Current sales taxes paid are for the State of Illinois (6.25%), the Regional Transportation Authority (0.75%), and most municipalities (rates from 0-4.75%). For example, the Village of Big Rock does not levy any sales tax, while the City of Geneva adds 1.0%.

The county revenue from this new sales tax would be dedicated exclusively to funding essential public safety services. This includes the Sheriff's Office, State's Attorney, Public Defender, Coroner, Circuit Clerk, Kane Comm 911, Public Health, and the Office of Emergency Management.

A Yes vote on the referendum indicates your support for the new tax; a No vote opposes the tax. Your vote is important.

<u>Annual Town Meeting - Tuesday April 8</u>

All township residents are invited to the Annual Town Meeting for Big Rock Township, which will be held on Tuesday, April 8 at 7:00 p.m. at the Town Hall. The agenda includes the township's Annual Financial Report, Supervisor's "State of the Township" report, and a summary of the Big Rock Road District activities during the past year.

The meeting will be followed by a reception to meet with your newly elected township officials who take office on May 15, and to recognize those stepping down from the board. Please join us at the 2025 Big Rock Annual Town Meeting. Best wishes for the coming Spring season!

PROPERTY MAINTENANCE/ZONING ENFORCEMENT OFFICER

This year, the Village is looking to hire an on-staff code enforcement officer. The Code Enforcement Officer will make sure to properly always identify themselves when visiting any property(s). Please note, they will be making drives throughout the community on a regular basis. The Code Enforcement Officer will be utilizing and referring to the Village of Big Rock's "Property Maintenance Code" and doing compliance checks accordingly. Our Code Enforcement Officer operates by observing the community, but also through anonymous complaints forwarded from our residents to the Code Enforcer. The Village does not control who is issued a citation, the Village can only forward any anonymous complaints for investigation. If you have a complaint about a property code violation, please contact the Village in the following ways: Leave an anonymous complaint on paper in the village mailbox outside the office, call the Clerk at 630-556-4365 and leave a message or speak to the Clerk about the complaint, or email admin@villageofbigrock.us. The complaint will be forwarded anonymously to the code enforcement officer to investigate. Just because a complaint is filed, does not mean that violations will be issued. If you have any questions or concerns about the code enforcement process, please reach out to the Village office or attend a Village Board Meeting to hear the latest news or voice your own opinion.

PROPERTY OWNER ANIMAL ETIQUETTE AND ANIMAL CONTROL SERVICES

It has come to the village's attention that recently we have had dogs off leashes and/or off their properties. Please remember that the village does have an ordinance to ensure residents are keeping their animals on a leash. This provides safety for everyone! If your animal happens to wander off and use others property as their restroom facility, PLEASE be courteous and clean up after them! In addition, the village has an IGA with Kane County to contract animal control to come out (for a charge) if the need arises. This charge will be billed to the homeowner if its deemed the animal(s) were in fact off leash and/or their own property. Please be respectful to those around you and make sure your animal(s) are under owner supervision & care at all times.

DOOR TO DOOR SOLICITATION

The Village has no ordinance against solicitors. With this being said we have received a few complaints of individual solicitors that are going door to door possibly representing themselves as village employees or having received a village endorsement for their specific sale(s). In ALL cases this is un-true! The Village of Big Rock does not partake in any door to door sales with/for our residents. The village can only suggest that if you are receiving unwanted solicitations on your property to place a sign on your door that clearly states: "no solicitors". If you have any questions about this please contact the village office directly.

Hinckley-Big Rock provides screenings for children birth to 5 who may be delayed in developmental milestones (communication, fine/gross motor, problem-solving, and personal-social). If you have concerns about your child's development, please contact Bonnie Osborne at 815-286-7578 or bosborne@hbr429.org to set up a screening appointment. These screenings are conducted by a team of District Educators and Specialists and are available to families living within the HBR School District. The screening will take approximately 30 minutes to complete. Afterwards, parents will have the opportunity to discuss the results of the screening as

well as any concerns about their child, with a member of the screening team.

Children 2-5 years old will participate in the screening with our team.

Children birth to 2 years old may be referred by our screening team for an Early Intervention evaluation.




