

TAX LEVY ORDINANCE

BIG ROCK TOWNSHIP ROAD DISTRICT

ORDINANCE NO. _____

An ordinance levying taxes for all road purposes for Big Rock Township Road District, Kane County, Illinois, for the tax year 2024, collectible in 2025.

BE IT ORDAINED by the Board of Trustees of Big Rock Township, Kane County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Big Rock Road District on December 12, 2024 does hereby determine and declare that the sum of

Three Hundred Eighty Eight Thousand, Four Hundred Forty Two Dollars (\$ 388,442)

is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

General Road Fund
Liability Insurance Fund
Social Security Fund
Permanent Road Fund
Bridge Fund

For the tax year 2024, collectable in 2025

SECTION 2: That the amount levied for each object and purpose shall be as follows:
