

## **TERMS AND CONDITIONS**

We operate on an appointment basis. Please call or visit the website to book a consultation or treatment.

Arrive on time. Please arrive alone. Arriving late may result in your treatment time being minimised or cancelled. Sanitise and wash your before entering the treatment room.

**NO CHILDREN UNDER 18 ALLOWED ON THE PREMISES** 

Consultations are £30. This will need to be paid at the time of booking. This is redeemable off any treatments or products. Card payments will incur a service charge of 2.5%. If you do not decide to book treatments or purchase products, £30 is used as your consultation fee.

A consultation form must be completed prior to your treatments please allow 30-40 minutes. You may also be asked to sign consent forms.

All consultations are strictly confidential, and will be done via a virtual platform, over the phone or in person.

All appointments require a deposit or full payment at the time of booking. Small treatments will need to be paid at the time of booking. A £30 deposit is required for treatments under £50. Over £50, a 50% deposit required.

Courses must be paid in full when booking your first treatment. Courses must be completed within six – eight months (refunds will not be given for incomplete courses.

## **CANCELLATION POLICY**

48 hours is required to cancel or re-arrange your appointment or treatments will be redeemed, deposits and payments will be non-refundable. You must call to cancel or re-arrange your appointment. No WhatsApp, text messages or emails are acceptable. We are closed on Sunday and Mondays. Office hours are 9.30am – 5pm

Vouchers are available and must be redeemed within 3 months.

For your safety the Aesthetic Practitioner has the right to refuse the treatment requested in certain cases.

Please inform us if you are pregnant, trying to get pregnant or feel you may be pregnant, breast feeding, taking medication, have any allergies, skin conditions or medical issues.
