Booths must remain in place for the entire event. Event organizers must be notified if for any reason, the booth will be unmanned during the event. Tear down must not begin until Sunday morning.

- Payment Policy: Payment is due with this signed contract.
- We ask that signed contract and payment be returned as soon as possible. (This policy is enforced to protect vendors from being heavily duplicated in wares. We appreciate your vending at our event and we want vendors to make money! If we receive your contract in an untimely manner, you could be denied a spot as a vendor due to the fact of duplication of such wares).
- There will be a return check fee of \$50.00 for any check returned for insufficient funds.
- Set-up Time: Check in for vendors will be 12:00 pm on or after Thursday August 13th, 2026 **or** Friday morning, before noon on August 16th, 2023. Event ends Sunday, August 16th, 2026 at noon.
- With your vendor contract and payment you will receive 2 vendor passes into the event. If any additional passes are needed, presale cost will be \$40.00 per pass. We ask that you make copies of our event flyer and advertise in your area for our event. Flyers are available for download (once available) at [www.godscountryabate.org](http://www.godscountryabate.org) under God's Country That Damn Party

#### **Rules and Regulations:**

1. All drawings for prizes or giveaways must be approved by event management.
2. No Walk-In solicitors.
3. Signs and merchandise must be displayed within your assigned booth area.

4. Any use of term "God's Country Chapter A.B.A.T.E. of PA." or "God's Country ABATE "That Damn Party" must be approved by the event coordinator.
5. Event hours will be Thursday (Early Bird – lighter crowd), August 13th, 2026 at noon through Sunday, August 16th, 2026 at noon. Everyone is to be off the premises by noon on Sunday unless other arrangements have been made with management of the event.
6. All persons must be 21 with ID to enter the premises. No Exceptions!

**Limitation to Terms, Conditions, and Rules:**

1. Neither event management nor any officers, agents, employees, and other representatives shall be held liable for any damage, loss, harm, or injury to person or property of an Exhibitor or any of its officers, agents, or employees.
2. The Exhibitor, at his/her own expense, may obtain any additional insurance they choose.
3. The Exhibitor is an independent contractor and in no way an employee of God's Country Chapter A.B.A.T.E. of PA or God's Country ABATE That Damn Party 2026.

**Assignment of Exhibitor Space:**

Management shall assign the Exhibitor Space to each Exhibitor for the period of the event. Such assignment is made for the period of this event only and does not imply that the same or similar space will be held or offered for future events.

**Exhibitor Conduct:** Exhibitor and representatives shall not solicit trade outside of designated booth area.

## **Licensing & Permits:**

The Exhibitor shall obtain any and all City, County, State, or Federal Licenses, inspections or permits required by law for operation of his/her display at his/her expense.
