### Proposed Budget - 7:08 pm

Income

The original income estimate was \$123,000. Due to the efforts of Ann Tooke collecting past due payments, this was increased to \$129,425.

Expenses

Estimated expenses were \$123,042. This was increased to \$129,425.

Reserves Total reserves are at \$102,000 of a total goal of \$149,000.

Bank account balances Income \$129,437.92 Current balance \$215,033.64 Forecast Dec 31st balance \$134,967.91

Budget change approval carries unanimously.

### Landscaping - 7:37pm

It is too late to do the aeration, so it was canceled. Watering is off while the city pours the new curbs. The monument flower beds have been disrupted by the new curbs. The curbs at the four southern monuments are done. The Circle Park refresh is on 7/20.

A proposal was made to renew park paths. The playground path is getting rough. The proposal is to dig out roots and smooth like the city has done for the sidewalks. Research into cost and whether to do it all at once, or in pieces.

Bark was missed at 32nd Ct, but finished with no charge. A proposal was made to add daffodils to improve that area. The tree wells were not barked this year. This may be better for the health of the trees, but there is some debate whether this is aesthetically acceptable.
