# **Finance Update**

- 2019 budget ended with an \$18,000 surplus which was added to the reserves as previously agreed to by the board. 2019 federal income tax return completed with \$0 owed in taxes.
- 2020 budget on track. All 2020 dues have been collected (30% collected via Zelle).
- Recording of Release of Lien for Lots 11, 31, and 32 with King County. The HOA paid the filing fees with King County Recorder to remove these old liens. In the future, the HOA will assign any/all lien costs to the homeowner's account.
- After investigating ML, Chase & credit unions, no viable investment account option for the reserves has been determined so far.
