- Completed barking on 32nd & 33rd neighbors quite happy.
- Due to COVID, the HOA could not proceed with Aeration/Lime/Over-seeding of the lawns; but did do moss kill. Too late to do anything else, will wait to next year.

 - Maintain trail between us and Sahalee. Quote from Monarch for a day rate to put down gravel.
 - Replace bark in playground, about \$1.5k

camper	 A trailer designed to launch, retrieve, and carry boats WA state definition of camper stated here: https://www.dol.wa.gov/vehicleregistration/campers.html A unit that slides onto the bed of a pickup truck intended for human habitation/lodging with or without cooking & sewage facilities OR Any vehicle with an interior or pop-up sleeping area OR Any vehicle intended for human habitation/lodging with or without cooking, electrical or sewage 		
mobile home	 Arry Vehicle Interided for Intilian Habitation/lodging with of without cooking, electrical of sewage facilities. WA state definition of motorhome: "A vehicle designed, reconstructed, or permanently altered to provide facilities for human habitation.
