Landscape (Andrew, Steve, Mi Jung)

- Tree permit, removal & replanting
  - 6 trees on trail were permitted & snagged/removed. 5 trees planted as replacements to provide screening on trails.
  - Andrew to review/clarify a proposal from Blue Ribbon tree to remove 3 additional trail trees.
- Tree requests for <u>healthy</u> trees the HOA gets frequent requests from homeowners and Sahalee residents for tree trimming of healthy trees on HOA property. The HOA's plan is to allow owners to submit a trimming plan by an ISA certified arborist which must be compliant with all city regulations. HOA will review the trimming plan and, if approved, the homeowner can proceed with trimming at their own expense. Only a *limited* trimming (less than 30% of branches) will be allowed; removal of healthy trees will not be allowed. If the tree is deemed unhealthy (including dead, hazardous or an imminent threat), the HOA will manage the tree's snagging or removal and any required replanting.
- Irrigation was turned off Sept 1 to manage water budget and some grass has turned brown. Flowers in park across from Blackwell have died and Mi Jung will work with Monarch to have them removed. Ann will also investigate if there is an irrigation issue in that location.
- Monarch mistakenly removed rhododendrons near tennis court. They will provide a replacement planting in a location of our choice as compensation.
- Trail Maintenance (debris & gravel)
  - To address debris from tree removal, HOA got quotes from Blue Ribbon and Monarch. HOA will proceed with a volunteer community clean up event first, paying for a chipper rental. If additional cleanup is required after the event, HOA will get updated quotes.
  - Mi Jung will get 2<sup>nd</sup> quote for trail head gravel refresh. With 2 quotes, the board will then decide whether to proceed with this project.
- 2021 Landscape Contractor selection Steve received proposals from Monarch, Malones, Progress, BrightView, and Brookstone. Steve recommends Brookstone, who also had lowest price. Board unanimously voted to select Brookstone.
