President's Report (7:08 pm)

Sport Court lock pilot

- Pilot lock program, while not costly, was not successful. Lock was stolen 3 times and tampered with once
- Post-pilot survey had 99 responses; results were previously posted to HOA website.
- Survey showed that more homeowners were satisfied than not satisfied with sport court availability
- Board investigated more secure gate/ lock options; these options were expensive and will not be pursued. Board will research alternate methods such as homeowner court access cards.

Dog Park and Off-leash Dogs

- HOA wants to reiterate that, per WA State, country & city laws, all pets must be on leash in public areas.
- HOA board looked into several possible locations on HOA property and fencing vendors; all options were very expensive
- Investigation also raised insurance/liability concerns. The HOA's insurance would not provide ongoing liability coverage in the event of lawsuits. (e.g. dog biting another dog or person).
- Given limited manpower on the board, the board felt the priority should be on maintenance of existing assets over the creation of new assets.

Comcast Proposal

- Survey results: 76% of responses are against the Comcast proposal (90 of 119 households)
- Board will ask those that volunteered in the survey to form a committee to investigate internet options for the neighborhood

Treasurer's presentation (7:16 pm)

- 2021 Dues collection was 100% thank you! (40% paid via Zelle)
- 2021 Tree & water expenses over budget
- 2022 Budget
 - Proposed Dues are \$725 per household, due Jan 1st, 2022.
 - Trees have been moved to a reserve component instead of an operating expense due to difficulty in accurately forecasting annual expense amount
 - o Increased water budget due to hot weather conditions & budget overages
- Audit expense will be added to 2023 budget.



Landscape Report (7:27 pm)

- January 2021 started working with Brookstone Landscape
- Had some challenges in the spring but getting better
- Bi-monthly walkthrough with owner and foreman
- Monument flowers did not look good because planting beds need roots removed and add new soil. Work to be done this spring.
- Working on getting more light into Circle Park. Rhododendrons have been trimmed and tall Pines will be limbed.
- Neighborhood volunteer event to be scheduled on November 21st (time TBD). Work will consist of: bulb planting at main entrance, weeding at end of NE 32nd Ct & trail clean up.
- Brookstone Landscape will continue in 2022.
- Leaf cleaning has been an issue
