The Children's HCBS Program (formerly known as the Katie Beckett Waiver Program and the Children's Medical Waiver) are waiver programs for disabled children who are at risk of institutionalization in a hospital or nursing facility and who would not otherwise be eligible for Medicaid due to parental income and/or resources.

### **Services:**

- The services provided under this program serve as alternatives to Medicaid hospital or nursing facility services for children, birth through age 17, and who meet the established minimum criteria for hospital or nursing facility level care as determined by the Peer Review Organization (PRO).
- The services provided through Children's HCBS Waiver Program should include all state plan Medicaid benefits and case management services.
- These services, when deemed to be appropriate and adequate by the child's physician shall be provided in the home or community.

### **Eligibility:**

SSI denial letter due to parent's income.  
Birth through age 17.  
Diagnosed developmental disability for the Children's Medical Waiver.  
This program does have an enrollment cap and often has a waiting list.
