I am also sending a copy of this to the court so that there is a record of it.

I also want it to be on the record that I find it offensive to be forced to give Brian my private information without accountability by the court for what he does with it.

However, I am expecting to have a source of income in the next month or two. I have a writer who is interested in telling my story about my experiences with the court system, two publishers, and a large marketing company who wants to help sell the book. I don't have any other way to pay for the fraud of a settlement arrangement that you don't have any evidence exists in the first place, nor does it exist in the court records.

While I recognize that this sets Brian up to drool over having your permission to be able to attack me again, please note, it will only make the book about the lack of ethics by so many people in the Minnesota legal system that much bigger.

Please remember that there is a great deal of documents and information already in the public domain or that belong to me that you have no say in what I or my writer can. Such as the settlement agreement for Brian's probation that talks about how he harmed so many people, or the letter from the staff at OLPR asking Justice Hudson to remove Susan from office. The judicial ethics complaint I filed that also contains the transcript proving you have no evidence of a settlement agreement is also part of a public record, and so is the response from OLPR that acknowledges Tim Maher's attempt to blackmail me into not contesting the arrangement for which you have no evidence of, and the police report is also public record. Brian's motion that states how he is able to file false claims in court because OLPR hasn't told him it's wrong to do so is also part of the publicly available records at OLPR and in the judicial ethics complaint. What also isn't there is anything with your name on it that says don't support that claim – you allowed it to stand.

The writer will be using what other people wrote, but I think you will agree that since you and Brian feel so strongly that the harm you have done to me is such a good thing, we ought to let others know about it. I can agree that I can't use the information in your records, but even you acknowledged you have no say over the information in the files of OLPR or the judicial ethics committee, and you certainly don't have any say over anything the Minnesota Bar Association says, either.

The best part is the enclosed email from the court stating my writer has permission to include your picture in the book. If I include a caption with it to the effect that "he's proud of this," or "this is what he feels good about", I am sure you can't complain about it. If this is how your court is supposed to work, let's not hide it. The only thing my writer can't include is the outcome of what you allowed Brian to do to me, but the process to get there is already in public records elsewhere. It just needs my writer to put it altogether.

Please make this file a part of my complaint against Brian VanMeveren, Laurie Cylkowski and Tim Maher.

This is a complaint I have filed against the judge who ruled in the case and has rewarded Brian for filing false, unsubstantiated claims and for lying.

Please note that Brian doesn't even deny that he has done these things. He's just counting on there being no grown ups in the legal system to tell him it is wrong. Brian – with Laurie's help – even filed a motion to say that he can file false claims in court because OLPR hasn't said it's wrong to do so.

If there was evidence and truthfulness on Brian's part, it would be one thing, but there isn't, and I, honest to god, would love to know why that's ok.

The June 12, 2023 hearing was supposed to be about Brian answering to charges that included fraud. That's what the trial was supposed to be about, so somewhere in there the judge had to have found substantial reason to proceed on that.

But when we get to the courthouse, Tim and Laurie have a secret meeting with the judge, and while they are off in chambers, Brian threatens me.

When they come back from their secret meeting it is to announce some sort of settlement arrangement that I never knew about, never agreed to, and it's not in writing. Half of what the judge is insisting on is not even in the court record, and he's also sealing the court record and not allowing the transcript to be shared, but he's insisting on screwing me over whatever happened in their secret meeting.

Tim tried blackmailing me into not rejecting the settlement arrangement he made in secret, but he also refuses to say why he refused to put any agreement in writing or why he agreed to a settlement arrangement that allows Brian to continue to harm me.

The judge knows Tim tried blackmailing me, but hasn't batted an eye over it. He just keeps dumping on me and supports Brian's claim to be a victim.

You can ask the judge for the records of both of the cases, and you will see that he has never required Brian to be truthful or support his claims with credible evidence, or any evidence at all.

I deserve better than this.

Please do the right thing and call this for what it is – wrong.
