We ask that everyone please keep their properties tidy by cutting grass and weeds, removing derelict and junked vehicles and eliminating unsightly items from their lots. The Bylaw Enforcement Officer, Rocky Coleman, is inspecting properties within the Village and issuing warnings for nuisance yards.

The Village helps people with the cleanup of their yards by doing back-alley pickups every Monday. Corley will gather leaves, grass clippings, etc. that are in tubs or compostable bags from the back alleys and haul them to the transfer station.

We ask that if you are doing a large tree trimming or tree removal project to please contact the office and arrange to utilize the Village's trailer instead of leaving a large amount for Corley to handle.

A reminder to everyone to please trim your trees and hedges along the sidewalks and the back alleys to keep them clear for people walking on the sidewalk and driving down the back alleys.

#### PARKING ON STREETS

According to our Parking Bylaw all trailers, campers, boats, etc. cannot be parked along the streets during the months of November to April.

Your camper can be stored at the Earl Grey Community Ball Park starting now until March 31<sup>st</sup> for the nominal fee of \$25.00.

#### **Water Main Flush**

The municipality is planning to flush water mains at the end of September. Please watch for notifications posted around town, on Facebook and on our website!

We ask that everyone please remove their garbage and recycling bins from the side of the street in a timely manner after they are emptied by Loraas Disposal. If the bins are not removed within 24 hours of being emptied, you can be fined \$25.00 per day that they remain out.

## Fire Insurance Coverage on your Property

<u>Important Reminder</u> A few years ago, we notified ratepayers of change in legislation regarding Fire Suppression Services. It is very important that each resident in the Village of Earl Grey to carry fire suppression services costs on your insurance policy for your dwellings. The ratepayer will be billed for the cost of any firefighting costs provided by the Earl Grey Fire Department and any other department dispatched to provide assistance to the Earl Grey Fire Department in the event of a fire. Currently the charges are \$4000.00 for the first 3 hours and \$2,000.00 for each additional hour after the 3 hour charge. <u>Please make sure you are carrying this on your insurance policy.</u> You must talk to your insurance provider about this coverage, our office cannot arrange this for you. Remember False Alarms charge is \$500.00 and Non-service calls charge are \$1,000.00.
