PLANNING TO BUILD

PLEASE NOTE THAT ALL BUILDING AND DEVELOPMENT PERMITS MUST BE OBTAINED AND APPROVED BEFORE ANY CONSTRUCTION BEGINS.

PROFESSIONAL BUILDING INSPECTIONS PROVIDES BUILDING INSPECTION SERVICES FOR THE VILLAGE AND ENSURES THAT ALL CONSTRUCTION COMPLIES WITH CURRENT BUILDING CODES AND LOCAL ZONING BYLAWS.

FOR QUESTIONS REGARDING PERMITS OR CONSTRUCTION REQUIREMENTS, PLEASE CONTACT THE VILLAGE OFFICE. A DEMOLITION PERMIT IS ALSO REQUIRED FOR THE REMOVAL OR DEMOLITION OF ANY BUILDING OR STRUCTURE.

TAX NOTICE INFORMATION

THE 2026 TAX RATES ARE UNCHANGED FROM 2025 WITH A BASE TAX OF \$1,100 FOR ALL IMPROVEMENTS (RESIDENCES), \$3.50/FRONT FOOT FOR RESIDENTIAL AND COMMERCIAL PROPERTIES AND A MILL RATE OF 2.00 MILLS. MAJOR ITEMS ON THE 2026 BUDGET ARE STREET REPAIRS, REPLACEMENT OF THE TRACTOR AND WATERLINE REPAIRS.
