### **2026 Utility Rates**

The utility rates will be adjusted in 2026 and the quarterly bill will consist of the following:

Water – 0 to 10,000 gallons \$155.00

Water – 10,001 gallons or more \$30.00 per 1,000 gallons

Sewer – Residences \$85.00 Sewer – Hotel \$120.00 Water Infrastructure – Residences \$50.00 Water Infrastructure – Hotel \$95.00

Therefore, the base residential quarterly utility bill will increase from \$280.00 to \$290.00 per quarter for water and sewer.

If you currently make monthly payments towards your utility bill and would like to increase the amount or if you would like to start making monthly payments please contact the office.

#### **SNOW REMOVAL**

When removing snow from your driveway/walkway this winter we ask that you please clear the snow onto your lot instead of pushing it across the street. When it is pushed across the street this can cause ridges if the snow on the street has already been cleared. New Bylaw 4-2025 to Control Snow Removal is now in place.

Also, we ask that everyone please remove their garbage and recycling carts from the side of the street in a timely manner each week so they do not interfere with snow removal through the winter months.

# **Christmas Lights**

The Christmas Lights have been hung around town and we hope that everyone is enjoying them when driving home from work or doing your annual "Sparkle Tour." Thank you to the Town of Southey for helping Corley hang the lights.

We ask that you please refrain from feeding the deer within the Village limits as that

attracts them into Earl Grey where they will harm the planted trees in yards.

#### **Business & Animal Licenses**

We would like to remind everyone to please renew your business license in January of 2026 by paying the annual fees. Also, please let us know if there are any changes to the number of animals that you may have. We have changed our dog (spayed or neutered) to a one-time fee of \$50 – effective January 2026.

**REMINDER...**Property taxes are due on December 31<sup>st</sup>. If they remain unpaid on January 1<sup>st</sup> then a penalty of 2% per month will accrue on all tax arrears on the first of each month.
