- mortgage, pledge or give security upon the property of the Village in connection with any loan or other liability or obligation of the Village to the Credit Union;
- generally exercise all rights, powers and authorities which the directors may exercise under the Village's constating documents; and
- withdraw from the Credit Union any securities or properties held by the Credit Union for safekeeping and give receipts therefore.

The Credit Union is authorized and directed to pay all instruments bearing such signatures by means of facsimile, rubber stamp, lithograph or impressed thereon by mechanical means. That this resolution be

communicated to the Credit Union and remain in force until an amending resolution has been passed by the Village and a copy thereof, properly certified, has been delivered to the Credit Union.
