# **FOCUS AREAS:**

Focus Area 1: Fondren Rd:

Vision: Relevant, cleaner look; hotel/lodging; improved identity for the corridor;

decorative lighting; distinguishing beautification features that let people know

they are in Missouri City. Police annex station

Focus Area 2: S Gessner Rd:

Vision: A more aesthetic, cleaner corridor; businesses that make sense for the

community; decorative lighting; innovative food hall in office warehouse park

Focus Area 3: Texas Parkway:

Vision: Gateway to the City; eye catching entrance from US 90A; Missouri City town

center, downtown; overpass connecting Texas Pkwy to S Gessner Rd; funplex with a movie theater, bowling and games; multiple housing choices; decorative lighting; high end retail options; zip line park; distinguishing beautification features that let people know they are in Missouri City; coffee shops, food trucks,

and out door cafes. Walkable places. Grocery store close to US 90A.

Focus Area 4: 5<sup>th</sup> Street & Independence Blvd:

**Vision:** Expanded 5<sup>th</sup> Street with covered ditches; zip line park; indoor sporting facilities;

Focus Area 5: FM 1092:

Vision: Redesigned commercial centers to have a more inviting feel/appearance; more

sit down, family restaurants; connectivity to American Legion Park by sidewalks and trials; vacant land use for a walkable commercial development; less wasted parking for development; grocery store in the old CVCS; Missouri City main road; nicer streetscape with signage, landscaping, and lighting; more townhome

options for young homeowners;

Focus Area 6: Cartwright Rd

**Vision:** Services for seniors, health care facilities; decorative lighting

Focus Area 7: Fort Bend Parkway

Vision: Entertainment area for Top Golf, bowling, race cars; Roadway beautification to

include flower beds along Watts Rd (east of Knight Rd); use of local artist/talent to beautify the toll road; sound walls along toll road; feeder road; corporate office

space;

Focus Area 8: Trammel Fresno Rd:

**Vision:** Mixed use, walkable, family friendly

Focus Area 9: Highway 6 (east of Fort Bend Parkway):

space and more trees and community gathering locations. Rice Village types of shops and restaurants. Multiple uses for the parking garage.

Convention center and hotels; medical facilities

Focus Area 10: Knight Rd / Watts Rd (east of Knight Rd) / McKeever Rd:

**Vision:** Green space between commercial and residential area; residential area;

10 feet wide sidewalks to allow for a place to walk, jog along roadways; Building heights limited to be below trees; wildlife preserve; beautiful stand-alone restaurants and cafes placed in the area of McKeever with airport viewing area; lower traffic generating uses along Watts; Lighting along Knight Rd and speed control to reduce drag racing up and down

# **GENERAL INPUT:**

## > Important factors to make Missouri City a great place to live, work, and play:

Development standards that will make the City look and feel unique
Local businesses that fit well with the neighborhoods; lots of dining, stores,
hotels, medical services; town centers, plazas, and gathering places
Practices to save the environment and protect nature

## Choosing to live or do business in Missouri City:

Home choice: perfect home, near family, great neighborhood

Location / accessibility: Regionally accessible; short commutes to work, shopping, recreation, church, medical

Natural environment: green space, wildlife, mature trees, non-concrete City

### Concerns:

Connectivity; lack of sidewalks and trails connecting to commercial development

Development that does not align with adjacent properties; boring big box and strip center development; No entertainment or destinations; food options

Increased traffic and flooding risk; loss of natural beauty surrounding neighborhoods; overbuilding

Lack of opportunities to receive communication and input from residents as it relates to the development activity
