

Call for Abstracts & Ideas

2021 Annual Meeting, February 8-9, Wild Dunes Resort, Isle of Palms, SC

The South Carolina Beach Advocates is accepting abstracts and ideas for its 2021 conference through **November 13, 2020**. Please submit your abstracts or ideas to exdir@scbeaches.org. Abstracts must include the name, title, affiliation, and contact info for the speaker (see attached abstract submission template). This year, we will be offering 15-minute speaking slots to encourage discussion.

"Abstract" - a short write up describing a presentation you'd like to give at a conference. It is like the Executive Summary of a report – includes info on the background, methods, results, and conclusions of a study. See the attached abstract submission template.

"Ideas" – tell us about a coastal management challenge or other state beach topic on which you'd like to hear a presentation or have a discussion about during our upcoming meeting. This is a less formal submission, just a quick email note will do.

Local Government and Community Associations have priority for speaking slots on the agenda, but we encourage all interested speakers to submit presentation abstracts especially if the topic is of interest or benefit to local governments and community associations. Industry abstracts are encouraged to partner with a stakeholder or a public agency (e.g., PPP – projects, studies, or topics relevant to public to private partnerships).

Student presentation abstracts are also strongly encouraged. See additional student opportunities below.

Suggested topics for the 2021 Annual Conference presentation include, but are not limited to:

- Recent nature-based (e.g., beach-dune, living shorelines, etc.) preservation projects, plans, and other developments in South Carolina and nearby states (e.g., North Carolina, Georgia, and Florida);
- COVID-19 response, closing & re-opening beaches, challenges, and lessons learned;
- Cultural heritage and preservation of SC coastal communities;
- Coastal resilience/adaptation plans or projects that address sea level rise and/or climate change;
- Flood mitigation strategies, drainage, and storm water management in coastal communities;
- Zoning or building code modifications to address coastal development challenges;
- Community monitoring efforts (beach/dune profiles, rainfall, tides, groundwater, etc.);
- Community engagement of residents/property owners in planning discussions (citizen science, crowd sourcing, new equipment/techniques, use of apps, etc.);
- Tools and technologies for shore protection (numerical modeling, GIS, data science, etc.);
- Innovative designs, approaches, and/or materials; and
- Benefits of shoreline and beach preservation (ecological, social, and economic).

Lead Presenter Bio: Susan Doe has been the Coastal Director at the Town of Anytown since 2011. Prior to that she worked as a technical staff person at DHEC OCRM. She has participated on the most recent committee on important coastal things and has 25 years of public service in the state of South Carolina.

Abstract: This oral presentation is about Anytown's beach recent nature-based preservation projects along its beach and marsh.
