The Enfield Montessori School reserves the right to submit delinquent accounts to a collection agency in the event that a family leaves the Enfield Montessori School with an unpaid balance and fails to make arrangements for payment acceptable to the school administration. The family of any delinquent account sent to a collection agency will also be responsible for all collection fees and any court fees that are incurred during the collection of delinquent tuition and fees.

Your child(ren)'s attendance at the Enfield Montessori School signifies your acceptance of this Annual Enrollment Agreement. Your signature indicates that you understand your financial obligations to the Enfield Montessori School and that you agree to fulfill them.
