Directions to site from I-5 Drive to Salem and take exit 253 (Hwy 22 W) and go toward Salem. Take ramp to right toward OR-99E-BR/Willamette University/City Center. Stay to right onto 12th St. and turn left on Center St. and continue west and move into left lanes to follow signs for HWY 99W Ocean Beaches. Go 9.6 miles and take ramp for Rickreall then left off exit onto N Pacific Hwy W (OR99W) toward Amity. Go approximately 18 miles and turn right onto SW Baker St (OR99W-N) about 3.5 mi, then right onto Lafayette Av. Fairgrounds entrance on right about half a mile. As you go up the hill, the big Red building on left is the Delashmutt Arena, unloading and parking is to the left behind the building. *Note: this is the easiest and usually quickest route but there are many ways to get to McMinnville.*

Trial Site. It is not appropriate to scout the trial location prior to the trial date.

CLASS TRANSFERS

Transfers to move up must be received no later than 30 minutes after last run each day for the next day. Transfers to correct errors in your entry(s) will be accepted no later than 30 minutes before the scheduled start time each day.

Mailed Transfers and E-mail transfers must include both owner and dog name, specific class entered and the change to be accepted until six pm on Wednesday December 12, 2024.

There will be no Videographer on site. Exhibitors may with Judge's permission have someone video their own search(s) on their personal phone or camera for their own use. No other individuals will be allowed to photograph or video searches at this event. See Regulations for AKC Scent Work Chapter 3, Section 14.

Important! Run Order & Schedules

DOG EXERCISE AREA – grass areas that are not posted as search areas or No Dogs. Dogs must remain on leash at all times and handlers should maintain at least six foot distance from other dogs. **Exhibitors are responsible for cleaning up after their dog(s).** Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

AGILITY GATE is a phone app we use for check in that allows you to keep up to date on how a class is moving. If you don't have the app, download the purple app now. The passcode is 2024 for this event. If you set the app to allow notifications you will receive immediate text messages sent through the program to let you know when a class is starting, or delayed, or preparing to close. You can also scroll to the bottom of the Agility Gate page to see all posted messages.

GATE STEWARD There is a second app called Gate Steward DO NOT attempt to use this unless you are indeed a gate steward assigned to help with a specific class at this event. Gate Steward only runs on Apple products so when a gate steward can't use it, they will mark dogs that have run in a class as a 'scratch'. If it's you and you haven't run, talk to the gate steward ASAP. If it's you and you have run, not to worry: It has nothing to do with our processing your results from the actual score sheet.

CONFLICTS IN AGILITY GATE. When you check in on Agility Gate each day you can mark you have a conflict. Please don't do that unless you are waiting in line for a search and see that your number is up to run in another class. That's the time to make a conflict so the steward for that search knows to not delay and will work you into the run order when you finish the other search you're doing.

START TIMES are approximate. After finishing judging a class, each judges needs to set up for the next class, get their demo dog to run it and adjust accordingly. All of our judges are also competing in some classes with their own dogs and that sometimes delays a start. Check Agility Gate for messages about when a class is ready to start.

HANDLER DISCRIMINATION will start first each morning. If you are due in another class while waiting for your HD run, please mark yourself as a conflict for the later class until you have run in HD.

BURIED & CONTAINER SEARCHES Arena is designed to allow you to run BOTH searches in the same level in the same pass. The Gate Steward for both searches will keep you organized to move along quickly. Be sure to maintain distance between yourself and other dogs in the area. If several people come in about the same time to line up, the steward may organize you to run in armband number order.

INTERIOR & EXTERIOR SEARCHES We try to also run these two searches in the same level together as well, but due to time it takes to run those searches, it doesn't work as well. When that happens, we try to adjust the armband run order to allow dogs with higher numbers to run first in one of those searches. It doesn't always work out that way. So keep an eye on Gate Steward and if you see your number is coming up mark yourself as a conflict then head over to check in when you finish the first search. We will do our best to have you stage for these searches in an open barn out of the weather. Be sure to maintain distance between yourself and other dogs in the area. If several people come in about the same time to line up, the steward may organize you to run in armband number order.

Event Results Preliminary results are posted as soon as we enter results. You may pick up your ribbons based on preliminary results when available. We enter results from the actual judges score sheets and Phyllis rarely makes an error. BUT, they are preliminary results and may change after the judge reviews each and every one of them. Often that doesn't happen until after everyone is gone for the day. If you think there is an error, please let the information desk know and we'll follow up on it with the judge when we can. If no one is there, just grab a transfer form and leave us a note that includes your name, dog name, element and class, and armband number. But please, DO NOT HARASS OR DISTURB THE SECRETARY. Each interruption means time away from getting your results entered and ready for judge review.


