

Our Goal







Changing Demographics

- •During 2017 2020 the female percentage of our military has increased from:
 - 16% − 17.2% on active-duty side
 - 19.6% 21.1% on reserve component side
- •During 2017 2020 the minority percentage of our military has increased from:
 - 26% to 27.5% on reserve component side
 - It has remained a steady 31% on the active-duty side

Changing Needs

"There is a lack of understanding of how the military family well-being varies by race and ethnicity, the concerns of minority families, and whether the Department of Defense is sufficiently meeting these families' needs in the performance of military duties."

Military Draw Down

- •Throughout the Cold War, the end strength of the U.S. active-duty force never dropped below 2 million.
- •From 1989 to 1999, end strength dropped steadily from 2.1 million to 1.4 million, where it has remained.
- •From 1945 to 1989, reservists were involuntarily activated by the federal government four times, an average of less than once per decade.

Increased Reserve Utilization

- •Reservists have been **involuntarily activated** for contingency operations by the federal government nine times since 1990:
 - Including large-scale mobilizations for the Persian Gulf War (1990-1991)
 - The aftermath of the September 11, 2001, terrorist attacks (2001-2022)
 - Coronavirus Disease 2019 (COVID-19) pandemic response
- Starting in FY2014,
 - Title 10, Section 12304 of the United States Code permits the President to authorize the involuntary activation of members of the Selected Reserve and the Individual Ready Reserve for a period up to 365 consecutive days.

Firsthand Experience

- No direct military support for my family.
- Lost income of approximately \$1000 per month.
- •The Reserve Air Force Major I relieved in November 2010, committed suicide in December 2010.
 - Leaving behind his wife and 2 young children.
- •During mail call a Reserve LtCol got served divorce papers.
 - Requiring me to secure him to the base as I conducted his mission.
- •Reserve Navy Commander ended up getting divorced 2 months after returning home from Iraq.



Veteran Suicide

- •In 2021, research found that 30,177 active-duty personnel and veterans who served in the military after 9/11 have died by suicide compared to the 7,057 service members killed in combat in those same 20 years.
- Military suicide rates are four times higher than deaths that occurred during military operations.

Veteran Homelessness

•Overrepresentation: In 2019, an estimated 8.1% of homeless adults were veterans, while veterans constituted only 6.9% of the overall population.

• "With the number of women entering the military continuing to increase, the care of female veterans is of major concern for VA and other veteran service organizations."

•"Veteran homelessness decreased by 50 percent since 2010. However, nearly all that progress was accomplished between 2010 and 2016. In January 2020, before the pandemic hit, Veteran homelessness started increasing again."


"There is an unmet need for Veterans Housing in the area as there are no such projects available in the city or county."


Project Description



- 18-unit housing complex in Amsterdam, NY
 - Two-bedroom, Three-bedroom apartments
- Basis for the design will follow USGBC Guidelines –
 "GREEN" TECHNOLOGY
- Four-story with parking located in basement (lower level)
 - 24,000s sf (not including parking level)
- Apartments 18,000 sf
- Communal spaces 6,000 sf
 - Communal kitchen
 - Communal dining
 - Communal recreation room
 - Lobby area (variable configuration)
 - Preliminary estimated construction cost \$7 10M


Lots Owned






10 Minute Walk
