## 5. Review of the P.O.A. Financial Reports as of 8/30/2025:

- We have in checking 57,325. and savings 47,498.

- Future Improvements Discussion

  - b) The Fishing Peir-Some boards need to be nailed down.
  - c) Water to the Peir-need quotes for pricing. The last time we looked into it they wanted \$2,000 to tap into the meter.
  - d) Mowing-Leather McCall wants to get back on a rotating mow schedule for twice a month in the summer and once a month in the winter. Mark Amell motioned, Charles Winegar 2<sup>nd</sup>. Request to ask Mr. Sanchez about killing grass in the road.
  - e) Lights-Request to look into putting light on road at the curve. Get quotes. Request for lights and fixtures to be replaced at entrance. Mark Amell motioned to replace front entrance lights and fixtures and 2nd by Neil McCall.
