Manager and Bardes hereby assign to Association, its successors and assigns, all rights, obligations, and privileges they have under the Declarations of Condominium (the "Declarations") and their supporting exhibits described on Exhibit hattached beauty and incompanied beauty by Exhibit A attached hereto and incorporated herein by reference.
- 2. Association, its successors and assigns accepts and assumes all rights, obligations and privileges of Manager and Bardes under the Declarations.
- 3. Association does hereby agree for itself, its successors and assigns, to indemnify, save and hold harmless Manager and Bardes and their successors and assigns from any loss, damage, claim, cost or expense arising or alleged to have arisen from the failure of Manager or Bardes, their successors and assigns to perform or exercise any of their rights or obligations under the Declarations, which indemnification shall become effective as to matters which arise after the effective become effective as to matters which arise after the effective date of this Assignment.
- This Assignment shall become effective upon its execution by Manager and Bardes and agreement to accept said assignment by Association.
