RESOLVED, THAT the Declaration of Condominium of Chateaux de Bardmoor #10 is hereby amended to include the following:

1. Condominium #10 is hereby authorized to join with other entities and or individuals to form and become a member of a corporation, partnership or other legally recognized entity (hereinafter referred to as "Maintenance Entity") for the purpose of operating, maintaining and/or improving the non-publicly dedicated areas in and around that certain dedicated public thoroughfare commonly known as Bardmoor Boulevard.

2. Any costs incurred by Condominium #10 with respect to its admission into and its membership in the Maintenance Entity shall be a Common Expense.

3. Condominium #10 is hereby authorized, without further vote of the members, to remove Condominium #10 from membership in the Maintenance Entity at any time it is deemed advisable. Upon removal of Condominium #10 from membership in the Maintenance Entity, the condominium shall not be readmitted into membership of the Maintenance Entity without first obtaining the approval of a majority of the voting interests of the Condominium.

RESOLVED, THAT the remaining terms, conditions and provisions of the Declaration of Condominium of Chateaux de Bardmoor #10 are hereby ratified, confirmed and approved.
