

ARTICLE V, MEETINGS OF MEMBERSHIP, Section 2, Annual Meeting, is hereby amended to read as follows:

SECTION 2. Annual Meeting: The regular annual meeting shall be held on a date and at a time and place as shall be set by the Board of Directors in the month of December each year. At the annual meeting the members of each condominium shall elect the director to represent that condominium, and elect directors at large, and approve the budget for that condominium for the coming year.
