## ÁDÓPTED AMENDMENTS TO THE DECLARATION OF CONDOMINIUM // OWNERSHIP OF CHATEAUX DE BARDMOOR INC., NO. 2, A CONDOMINIUM

The following are adopted amendments to the Declaration of Condominium Ownership of Chateaux De Bardmoor Inc., No. 2, a Condominium, originally recorded in Official Records Book 3253, Pages 67-82 et seq., within the Public Records of Pinellas County, Florida, as subsequently amended:

Section 15 of the Declaration of Condominium Ownership of Chateaux De Bardmoor Inc., No. 2, a Condominium, is hereby amended as follows:

15. Maintenance: The responsibility for the maintenance of the condominium unit and parcels shall be as follows:

- (c) Material Alterations and Substantial Additions by the Association.
  - (1) The Association is authorized to undertake alterations, additions or improvements to the common elements that are required for the Association to perform its maintenance duties as set forth herein, or that may be required by law, or that are required in the event of an emergency, or to protect the health, safety and welfare of the community, without the need for a membership vote.
  - The Association shall have the authority to change the paint-color of any common elements without a membership vote, provided the color of colors used are consistent with a color palate developed and adopted by an appointed committee. The paint color committee shall be comprised of not less than five committee members, the majority of which shall consist of unit owners who are not members of the Board of Directors. Notwithstanding the foregoing, the color of a residential building may not be changed without the consent and approval of 75% of the owners residing in such building. Furthermore, no paint color that is not on the approved color palate may be used on the exterior of a residential building without further approval of the Board of Directors.
  - The Association shall have the authority to undertake other alterations, additions or improvements to the common elements provided the costs associated with such undertaking(s) shall not exceed ten percent (10%) of the total operating budget of the Association, in the aggregate, in any twelve month period. Any alterations, additions or improvements exceeding the ten percent (10%) threshold must first be approved by the affirmative vote of a majority of the unit owners of the Association. Any such alteration

or improvement shall not interfere with the rights of any unit owner without the unit owner's consent.

Section 26 of the Declaration of Condominium Ownership of Chateaux De Bardmoor Inc., No. 2, a Condominium, is hereby deleted in its entirety:

26. SUBSTANTIAL ADDITIONS OR MATERIAL ALTERATIONS TO COMMON ELEMENTS.

Notwithstanding anything to the contrary obtained herein, the Board of Directors shall have the authority to make material alterations or substantial additions to the common elements upon receiving the written approval of at least seventy five (75%) percent of the voting members of the Association.
