### **SPILLWAY REPAIR UPDATE:**

The Board of Directors is pleased to inform you that the chemical grout installation at the spillway several months ago was successful and stopped all water flow under the concrete spillway. Periodic monitoring has revealed no water flow from under the spillway in the areas previously observed. The chemical grout repairs were concentrated along the concrete headwall at the top of the spillway and continued down the spillway western edge of the concrete apron to approximately 70' from the lower toe wall, where the available materials and labor contract expired.

Several weeks ago, Board members and residents made a hand-dug survey at some areas observed to have earth separated along the lower spillway edge to gauge the possibility of filling the remaining voids with granular bentonite materials. It was immediately apparent the void areas were too large for this application. We then procured fill dirt and brought in an excavator and skid steer loader to address the voids. The first excavation just below the last grout injection location revealed a large void extending under the spillway further than we could feasibly place the dirt to fill the void completely. Fill dirt was placed to the extent possible to help support the outer edge of spillway concrete. Two additional excavations were performed, approximately halfway to the toe and at the lower toe wall. These excavations revealed the large void appears to extend in an apparent continuous manner from the last grout injection location all the way to the toe wall. I want to say thank you to members Page VanCleave and Nick Foster for providing their time and equipment to assist in this work.

The Board is actively exploring multiple methods to complete the spillway remedial repairs in the most cost-effective manner possible. We have engaged Mr. Rick Howe to provide technical and engineering services to assist in the completion of these repairs. Before any additional repair work is scheduled, the Board contracted with a local provider to perform a ground penetrating radar survey of the entire concrete spillway structure to assist in identifying known and/or unknown voids to help determine the scope of work and required volume of materials required to make the repairs. We will keep the membership informed as we move forward.

## 333 SNAKE PIT 3333

## Diamondback Water Snake Nerodia rhombifer

I decided to focus this Snake Pit on the most seen, and misidentified snake on our lake......the harmless Diamondback water snake.

Identifiers for this snake will be its brown to green coloring, maybe darker as it ages, and dark vertical bands, when viewing from the side. From the top, the dark markings will take on a chain-link appearance. These will also be harder to distinguish as they age.

Like all water snakes that we will discuss, there is one common identifier that should help you determine that it is in fact, a water snake. All our water snakes will have dark, vertical labial lines that cross their mouths. The Diamondback is also the largest water snake that you will encounter on the lake.

Should you see a large group of snakes mating on the banks, you are seeing a female and many male water snakes. Our venomous snakes do not mate in groups. That's right, venomous snake pits do not exist in our area.

You will most likely encounter this snake on the water's edge, whether it be lounging on a tree branch, hanging from a branch fishing, or resting on a dock or boat. Should you approach, they will normally flee quickly.

Diamondbacks are fishers and are catfish specialists.

In my experience, and my experience only, I have noticed that Diamondbacks seem to be a curious snake. Many times, I have had them swim toward me, when I expected them to flee. A simple wave of the arms usually convinces them to leave the area or go under water.

As with all other snakes, this snake is not aggressive and will only bite if it feels threatened.
