I _____ doing business as _____, as well as, any person(s) helping and or running my business, by signing this contract, hereby agree to abide by the following at the Sweet Violet's Vintage Market Friday, April 19th and Saturday, April 20, 2024 from 10:00 a.m. to 4:00 p.m. at 711 Pocket Road Hurt, Virginia 24563 (white Barn Vintage).

- All vendors must be prompt and present at the vendor meeting Tuesday, April 16 at 6:00 p.m. Important information such as move in dates and times and space selection will be given out. For those of you who reside out of state or for special circumstance, please let us know in advance so we can get you everything you need.
- We encourage you to be creative as possible with your event space. This can include your business sign. We will do a final check of space prior to the event opening.
- All spaces must be ready for business by end of day Thursday, April 18.
- The event will be open from 10 a.m. through 4 p.m. Friday and Saturday. All vendors must remain "open" at the sale until the event is over at 4:00p.m. Saturday and may not begin packing up until then.
- All vendors must provide their own tables, chairs, displays, tent is not necessary unless not in a covered area or any other necessary items that are appropriate for your space. Each vendor is responsible for setting up and taking down their complete display.
- The vendor fee must be paid and submitted with the signed agreement. The vendor fee in non-refundable. We will accept cash or check. The last day to submit a payment is Saturday, February 28th space permitting. Space is limited and will not be held without payment in full and a signed vendor agreement.
- All vendors are encouraged to obtain/provide their own event insurance that covers and protects them for any liability as well as their space, goods, merchandise and services that are provided during the SVVM event. WBV cannot guarantee insurance liability coverage or protection and are not responsible for any damages, personal or financial, that occur or are a result of activity at your "designated area" event space.
- All vendors are invited to provide a small item for marketing/promotional giveaways. Be sure to choose something that best represents your business or brand. Don't forget to attach a business card! Please submit these prior to or at the Vendor Meeting.
