Vaya Con Dios

he only thing constant is change, said somebody at some time – and it's daily realized by a lot of people a lot of times. Even if we (perhaps foolishly) believe we are living in the best time possible, it cannot be forever. Your humble author came up against this basic reality November 30, the date of my retirement from USCDWUA. I decided that after 40 years, it is time for me to get out of the way.

In 1977, at age 33, I first picked up a shovel on behalf of this beloved company. That winter, the "Winter Without Snow," I found myself installing pipelines along Ute Trail Road – known at the time as "Muck Lane," and 2375 Road – then called "Robotham Lane." The season following the Winter Without Snow became the Summer Without Water, the worst drought in my memory. That year was also memorable for the Denver Broncos' first trip to the Super Bowl, where they were rudely treated by the Dallas Cowboys. It would be 20 more years before Denver actually won a Super Bowl. This year, it will be shocking if they win a regular season game.

In 1977, the size of USCDWUA was 320 members. The office was housed in a converted back porch. The maintenance department lived in the back of a pickup. Board meetings were held as needed, sometimes one or two per year. Now we have an office and shop, regular monthly meetings, a water treatment plant, 105 miles of pipeline, and 1,014 members. Yeah, it's changed.

Yet, in seeming contradiction to the opening sentence of this letter, the more things change, the more they stay the same. There's a French version of that saying, but I don't know what it is, except I think the word "plus" occurs a couple of times, and there is a letter C with its tongue hanging down, and a letter E with a raised eyebrow, which is why I don't read French. It means that the challenges facing this water system forty years ago are facing us yet today. How to make sure we have enough water. How to make sure the water is safe. How to make sure the water tastes okay. How to make sure the pipes are large enough to support a growing population. How to make sure the pipes are not so large that the water stagnates. How to set our rates so that members are treated fairly and not bankrupted. How to comply with regulations imposed by government agencies, particularly when regulation 11.2a.(i) seems to be in direct opposition to regulation 13.4b.(iv). How to keep up with the cost of doing business in this inflationary world. Inflation – now there's a constant for you. It shall be with us always.

Dealing with all the above is a game for younger minds and younger bodies. It used to make my head spin – now it spins all by itself. Truly I will miss a lot about this job, and most of all I will miss the interaction with you, the members of the Association. You have always been supportive of our Board and staff, and have cooperated voluntarily when asked to conserve water, attend the annual meeting, send proxies, and in general make our job easier. To all of you I say thanks, and though my French is nonexistent, I have just enough Spanish to say *vaya con Dios*
