The amount we are asking for is about \$15,000,000. \$6,000,000 is for the treatment plant to install the GAC filters and replace the Pall micro filter system. The rest is to replace the rest of our Galvanized lines, which is almost 9 miles. The process does take time before we have a result but it is proceeding. One thing to note is that USDA will not loan more money than is reasonable for the association.
