Update on Reservoir Purchase:

Town of Cedaredge has decided to pursue the purchase of the reservoir on their own.

Education/Certification:

Kurt and Jed have both been registered with the American Water College online for III Distribution and II Distribution. Once they get their license in distribution then they will start the treatment. Pall systems will come out for three days and go through the equipment and train everybody on the system for \$15,000. Possibly Hotchkiss would like to join.

2023 Budget:

A preliminary budget was discussed. We need to look at a loan for distribution upgrades.

Election of Board Members:

Brad Stratman resigned from the Board of USCDWUA effective immediately.

MOVED BY Ken Besel to accept Steve Hanson to fulfill the rest of Brad Stratman's term as a Board Member of USCDWUA.

SECONDED BY John Walker

MOTION CARRIED with no opposing votes.

Old Business:

Water Line Replacement: Cactus Park Rd is underway so far 1,500 ft has been installed. With leftover pipe from this project, we can do T75 Rd.

Reconnect with Cedaredge: The Cedaredge Town Administrator is interested in a reconnection for Emergencies.

<u>Valve Locations:</u> Work is progressing on GPS Valve locations, at least 50% done.

Financial Review: Randy has the information to do the financial reviews for 2019, 2020, and 2021.

Fire Hydrants: Fire Hydrants for 2900 Rd & P25 Rd will be installed

Lead & Copper: If we have another exceedance in Lead, we will have to proceed with Engineer requirements to add PH to water.
