

## Pool Hours, Rules, and Regulations

### 2023 Pool Hours:

May 27 – June 18, 2023 Weekend Only

11:00 am – 7:00 pm

June 24, 2022 – Sept. 4, 2023 Daily

11:00 am – 7:00 pm

1. A lifeguard must be present at all times. Swimming is not allowed if a lifeguard is not present.
2. All Members are responsible for registering themselves and their family members with the COVID Ambassador upon entering the pool area. This year you must show your SLC Membership Badge to the COVID Ambassador to enter. The Ambassador is also responsible for wiping down the chairs, etc. between guests and ensuring we follow the NJ Governor's COVID guidelines.
3. **All Members are responsible for registering any guests with the Ambassador and must accompany the guest while in the pool area.** Please list all guests on your designated member sheet sign-in, in the pool book, and sign them in upon entry.
4. **All members are required to pay a guest fee of \$5 per adult or child age 5 and over and must accompany their guest(s) at the pool at all times. Guest fees are billed to the member at the end of the pool season. A seasonal guest pass is available for \$50 for Resident Members and \$75 for Social Members.** A seasonal guest pass may be used by someone living with you, for the summer, such as extended family members, friends or foreign exchange students, au pairs, and/or babysitters. Please contact the Club to obtain a guest pass.
5. Persons who show signs of illness or who have any kind of infection, suspicious skin rash, poison ivy or open wounds of any kind will not be permitted in the pool.
6. All children who are not fully toilet trained will be required to wear a diaper cover over their cloth or disposable diaper before entering the pool area.
7. Swimmers from age 6, or first grade, to age 16 must go to the lifeguard to set up and take a deep water swim test before being allowed in the deep end of the pool. The lifeguard will record who has passed the test.
8. If a guardian or parent wants a child or children under the age of 6 or first grade or has passed the deep water test, to swim in the deep end of the pool, that guardian or parent must be in the deep end of the pool with the child at all times.
9. **No member or guest UNDER THE AGE OF 10, will be permitted in the pool area or the pool without an adult or responsible guardian (16+ years of age) present at all times.** Lifeguards are not to be viewed as babysitters.
10. The deep-water test consists of performing the following water skills. First the young swimmer must be able to "jump" into the pool at the deep end. Then he/she must be able to swim from the deep end of the pool to the shallow end and back to the deep end (one complete lap). When he/she arrives at the deep end, he/she must be able to tread water for approximately one minute. If the individual can perform the above-mentioned water skills, then he/she would have passed the deep-water test and will be allowed to swim in the deep water of the pool without a parent or guardian present in the water and at the sole discretion of the lifeguard.
11. Young swimmers who have not passed the deep-water test cannot enter the pool unless accompanied by a parent or other adult at poolside.
12. Diving and running in the pool area is NOT permitted.
13. No ice cream or glass is permitted within the pool area.
14. At no time is the consumption of alcoholic beverages by minors permitted on Shadow Lake Property.
15. Vandalism, destruction, or defacement of Shadow Lake Property will cause immediate suspension of club privileges and possible further action by the Board of Trustees.
16. No horseplay of any kind will be allowed in the pool area. This includes pushing, shoving, fighting, throwing objects, etc. It will be at the sole discretion of the lifeguards which actions fall within this description.
17. Disruptive behavior, use of foul language or refusal to adhere to the requests and instructions of the lifeguard(s) will result in suspension of pool privileges as determined by the Board of Trustees at their sole discretion.

18. The pool area must be always kept clean. Upon leaving, please deposit your trash in the garbage cans provided. Large pizza boxes should be deposited directly in the dumpster at the rear of the clubhouse.
19. The pool may not be rented for parties on the weekend. Renting the Shadow Lake Clubhouse does not entitle the Member to use of the pool. However, if you are renting the clubhouse during the week (M-F), you may bring up to 20 guests to the pool provided you arrange for an additional lifeguard and pay for your pool guests. Arrangements for an additional lifeguard would be made directly with A Squared Management, the pool management company used by Shadow Lake.
