- All Vendor Applicants AND their employees/helpers must be **21 years of age or older**. Persons under the age of 21 will not be allowed to attend the NC Bourbon & Spirits Festival - **No Exceptions**.
- Applications are for consideration only and spaces will be limited. Applications must be filled out in full in order to be considered. Someone from Weldon Mills Theatre will contact you via email or phone upon approval of your vendor application. Once approved, further instructions, including how to pay for your vendor spot, will be emailed to the email address you provided on the application.
- Rain or Shine - NO REFUNDS once Vendor Application is approved. The governing body of NC Bourbon & Spirits Festival Committee reserves the right to CLOSE the festival due to extreme weather or public safety concerns, without a refund to vendors.

# 2024 NC Bourbon & Spirits Festival Release and Waiver of Liability for Vendors

1. **Waiver and Release.** I hereby release and hold harmless the NC Bourbon & Spirits Festival, CARIDA Capital Group, CARIDA Operations, Weldon Mills Distillery, BarnBurner Promotions and its successors and assigns from any and all liability, claims, demands, and causes of action, of whatever kind of nature, either in law or equity, which may hereafter arise from my participation and the participation of anyone working for me with the NC Bourbon & Spirits Festival, CARIDA Capital Group, CARIDA Operations, Weldon Mills Distillery and BarnBurner Promotions or any project, activity or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with the NC Bourbon & Spirits Festival, CARIDA Capital Group, CARIDA Operations, Weldon Mills Distillery and BarnBurner Promotions.

Any coverage so provided will be governed by the policy language. Except to the extent that it may provide such insurance, NC Bourbon & Spirits Festival, CARIDA Capital Group, CARIDA Operations, Weldon Mills Distillery and BarnBurner Promotions does not carry or maintain any health, medical, disability, damage or other liability insurance coverage for the benefit of its vendors, and expressly disclaims any responsibility or obligation to do so. The Certificate of Insurance will include coverage in the amount of \$1,000,000 for CARIDA Capital Group, LLC and CARIDA Operations, LLC, as Additional Insured.
