## Release and Waiver of Liability Magnolia Crappie Club

- 2. I am aware that operating or riding in motorboats and participating in tournaments poses potentially serious risks of injuries or death. I am aware of the intrinsic dangers of boating and fishing activities. I understand that I may be injured or die because of my negligence, the negligence of others, or through no fault of myself or anyone else, because of the nature of the activity in which I am going to be engaged. - 3. This waiver shall remain valid unless expressly revoked by the participant or parent or guardian of a minor, in writing, with receipt acknowledged by an officer of The Magnolia Crappie Club.
- 4. With the knowledge of the foregoing, and as an inducement for The Magnolia Crappie Club to allow me to participate in all tournaments from August 2023-July 2024 season. I hereby agree to waive or release any and all rights that I or my heirs may have to make a claim against The Magnolia Crappie Club, it's Governing Board of Officers and Directors, employees, and its sponsors, arising from any damages, injury, or death which I might sustain.
