Release and Waiver of Liability Magnolia Crappie Club

By signing this document, I am certifying that I have fully read, acknowledge, and understand the following:

1. I have read and agree to abide by the current Rules & Regulations of The Magnolia Crappie Club, to include being subject to a Boat Inspection and a Polygraph Test.
2. I am aware that operating or riding in motorboats and participating in tournaments poses potentially serious risks of injuries or death. I am aware of the intrinsic dangers of boating and fishing activities. I understand that I may be injured or die because of my negligence, the negligence of others, or through no fault of myself or anyone else, because of the nature of the activity in which I am going to be engaged. I understand that acts of God and the actions of other participants are often unpredictable and uncontrollable.
3. This waiver shall remain valid unless expressly revoked by the participant or parent or guardian of a minor, in writing, with receipt acknowledged by an officer of The Magnolia Crappie Club.
4. With the knowledge of the foregoing, and as an inducement for The Magnolia Crappie Club to allow me to participate in all tournaments from August 2024-July 2025 season. I hereby agree to waive or release any and all rights that I or my heirs may have to make a claim against The Magnolia Crappie Club, it's Governing Board of Officers and Directors, employees, and its sponsors, arising from any damages, injury, or death which I might sustain, or which might occur from any damages, injury, or death which I might sustain. I further agree to indemnify and hold harmless all the foregoing from any claims which I might make, or which might be made on my behalf by others, or which might be made against me by others, arising from participation in fishing tournaments. Furthermore, I agree to indemnify The Magnolia Crappie Club, its Governing Board of Officers and Directors, employees, and its sponsors, for any injury, death, loss, or damage to any personal property which might occur during a Magnolia Crappie Club activity or social function sponsored by the Club or held in its behalf or for its benefit.
5. I understand that this waiver is valid for all "fruit jar" fishing tournaments, regular season tournaments, and all activities or social functions sponsored by the Club or held in its behalf or for its benefit in which I participate for the entire season of 2024-2025 and a separate waiver for each event in which I participate will not be necessary.

I hereby give my consent to Magnolia Crappie Club and its agents and assign, to publish and otherwise use my **photograph**, portrait, or likeness of me and my name, in any connection therewith for editorial, audiovisual, advertising, and trade purposes, without limitation or reservation.
