SMS opt-in consent and data will not be shared with third parties. You may opt out at any time by replying STOP.

How We Use Your Information

We use your information to:

- Provide information you request
- Improve our outreach efforts

We do not sell your personal information.

We may share your information with trusted service providers (such as email or text messaging platforms) solely to support campaign operations. These providers are not permitted to use your information for any other purpose.

Children's Privacy

We do not knowingly collect personal information from individuals under the age of 18. If you are under 18, please do not submit personal information through this website.

Consent to receive messages is not required to make a contribution.

User Opt-In

By providing your phone number and opting in, you:

- Authorize Kit Johnston for Yamhill County Commissioner to send campaign-related messages
- Understand messages may be sent using automated technology
- Agree to these Terms and Privacy Policy

User Opt-Out

You may opt out of the Program at any time by:

- Replying STOP to any message
- Replying HELP for assistance

After opting out, you may receive a final confirmation message.

User Responsibilities

You agree to:

- Provide accurate and truthful information
- Notify us if your phone number changes
- Opt out before transferring or disconnecting your number
- You agree to indemnify and hold harmless Kit Johnston for Yamhill County Commissioner and its service providers from any claims resulting from failure to notify us of changes to your contact information.

Data Use & Privacy

We do not sell, rent, or share your personal information, including SMS opt-in data

Your information may be shared only with trusted vendors to deliver messaging services
