Consent must be provided using the "Consent to Cancellation" form issued by the Club. Selling the progeny of a dog covered by such an agreement as purebred at the time of service constitutes a violation of the Animal Pedigree Act. The completed Consent to Cancellation form, along with the dog's Certificate of Registration, must be submitted to Membership Services at the specified address.
