

Instructions for the completion of Application for Registration of a Litter(s)

Section A – Dam

1. The Dam MUST be registered with the Canine Kennel Club (aka CKC.club aka CKC.world).
2. Registration for litters of Belgian Shepherd Dogs, Chihuahuas, Collies, and Dachshunds is subject to special regulations. Additional regulations for these and other breeds may be obtained by contacting Canine Kennel Club Membership Services at (778) 312-1888.
3. If this litter was produced using artificial insemination with frozen or chilled semen, please complete the Artificial Insemination Registration Package.
4. The signature(s) of ALL recorded owner(s) of the Dam at the time of the litter's birth are required in Section A (1) of the Litter Application.
5. If the Dam was transferred or leased in whelp, the signature(s) of ALL recorded owner(s) at the time of mating are required in Section A (2) of the Litter Application.
6. Recessive Coat Litters: If this litter includes pups with recessive coat types, specify the coat type when completing the application to register each dog individually.

Section B – Sire of Litter

1. If the Sire is registered with the Canine Kennel Club (aka CKC.club aka CKC.world), ALL recorded owners at the date of service must sign this section of the application.
2. If the Sire is owned by a non-resident, the Sire must be registered with the Canine Kennel Club (aka CKC.club aka CKC.world) in the name(s) of the person(s) certifying the service to the Dam. The signature(s) of ALL recorded owners must be provided in ink. The completed application must be forwarded by the breeder or stud dog owner to the Canine Kennel Club (aka CKC.club aka CKC.world) for certification.
3. A COPY of a certified three-generation pedigree of the Sire, issued by the Canine Kennel Club (aka CKC.club aka CKC.world), must accompany this application.
4. A DNA parentage profile is required to accompany a litter application for any male dog from a registry or foreign stud book, recognized or unrecognized by the Canine Kennel Club (aka CKC.club aka CKC.world), that has sired a litter on or after July 1, 2020. Without this DNA profile, registration of the litter will not be entertained.
5. DNA Parentage Profiling is required for all foreign stud dogs whose semen has been collected for fresh, chilled, or frozen use to produce any litter requiring Canine Kennel Club (aka CKC.club aka CKC.world) registration.
6. The DNA profiling will provide the Canine Kennel Club (aka CKC.club aka CKC.world) with the resources to verify the authenticity of parentage by comparing the DNA profiles, when necessary.
7. If the owner of the Sire is not a resident of the applicant's country, an original Stud Service Certificate and a copy of the certified three-generation pedigree issued by the recognized Foreign Stud Book are required. In this case, Section B of this application does not need to be signed by the registered owner of the Sire if the signature of the stud owner(s) appears on the Stud Service Certificate.
8. If the Owner/Lessee of the Sire refuses, fails, or neglects to sign the application without justifiable reason when requested, the Registration Committee may authorize registration in accordance with Section 13 of the Canine Kennel Club (aka CKC.club aka CKC.world) By-laws.

Note:

In accordance with the Policy and Procedures, a litter is eligible for registration if the Dam of the litter was mated with two or more stud dogs. DNA verification will be required.

Payment must accompany this application. For applicable fees, please refer to the Canine Kennel Club aka CKC.club aka CKC.world Schedule of Fees at (www.ckc.club).

The following additional fees will also apply:

- An additional manual processing fee will apply when submitting your application to the office for processing.
- A paper certificate fee will apply when requesting a printed certificate. (PDF certificate is free of charge.)
