This Nevada Association of Community Managers Affiliate Membership Agreement ("Agreement") is entered into on $_{_}$	("Effective Date") between the
NEVADA ASSOCIATION OF COMMUNITY MANAGERS, Inc. ("NACM") a Nevada Corporation, and	("Affilate").

1. DEFINITIONS

"Member" means any Management Company, Affiliate, Manager or Candidate Manager Member of NACM as defined by the Bylaws. "Board" means the Board of Directors of NACM.

"Executive" means any management company member as defined by the Bylaws.

"Manager" means any community manager member of NACM as defined by the Bylaws.

"Signatory" means Member or Member's agent or employee who represents said company when signing contracts or agreements.

"Sponsorship" means payment submitted to NACM by a Management Company Member for the purpose of conducting an event.

2. GENERAL

NACM reserves the right, from time to time, to make changes to this Agreement. Whenever practical, notice shall be given to the Members of NACM and changes shall take effect in accordance with the notice. Changes to this Agreement shall not modify the status of any Memberor give any Member the right to cancel their membership.

If any provision of this Agreement shall be deemed invalid, void or for any other reason unenforceable, that provision shall be deemed severable and shall not affect the validity and enforceability of the balance of this Agreement.

NACM encourages Members to review the Membership Policies, which is incorporated in and a part of this Membership Agreement. (Accordingly, by becoming a Member you are agreeing to be bound by the Membership Policies, and a violation by a Member, or employee or agent of the same would also constitute a violation of this Agreement.)

9. TERMINATION OF MEMBERSHIP

Member understands that we may exercise this right in our sole discretion. We also reserve the right to disable or terminate a Member's website account or displayed logo and remove their listing from the directory without notice.

10. REPRESENTATIONS AND WARRANTIES
