

ome November 3, 2020, we will have the choice to make a difference and effect much-needed change to our lives – our health, welfare, education, pensions, economy, infrastructure, and more.

Most importantly, we can restore our basic rights as citizens regardless of color, ethnicity or religion.



The U.S. Senate and its Republican majority are proposing the Heals Act, which falls far below our needs. Political Department Report

awaii's first mail-in primary election is in the history books. On August 8, 2020, a record number of voters participated in a Hawaii primary election. Although there were some close races, the mail-in process proceeded smoothly and without significant controversy.

Many of the candidates endorsed by District Council 50 and your local unions fared well in the primary. Of particular note is Honolulu mayoral candidate Keith Amemiya, who started out in the middle of a crowded field but surged ahead of other candidates to finish second in the vote count. Keith will now run in the General Election in November. A list of the candidates that DC50 has endorsed is printed on pages 4 and 5.

You may have heard in the news that Joe Biden and Kamala Harris were chosen as the Democratic Party nominees for the 2020 Presidential election. The IUPAT has endorsed both Biden and Harris in the 2020 Presidential election. In his nomination acceptance speech, former Vice President Biden specifically mentioned his belief in and open support of unions – a most welcome contrast from four years of Donald Trump's incessant attacks on unions and working-class people.

General Election Information

The General Election will be held on November 3, 2020. Once again, this election will be by mail-in ballot. All registered voters should receive their ballots for the General in the mail by October 16, 2020. Mail-in ballots must be received by your County Elections Division by 7 p.m. on Election Day. Any ballots received after 7 p.m. on Election Day will not be counted, so please make sure to mail your ballots at least three to five days before Election Day. Mail-in ballots can also be dropped off at Voter Service Centers and designated Places of Deposit.

Walk-in registration and voting will also be available at Voter Service Centers beginning on October 20, 2020. Walk-in voting at Voter Service Centers will remain available until 7 p.m. on Election Day. A map showing the Voter Service Centers and Places of Deposit, together with their hours of operation, can be found through the link to the State Office of Elections' website below.

Union Office COVID-19 Protocols

District Council 50 is continuously assessing its operations so that we can continue to provide excellent member services and ensure a safe workplace. Some of the changes that have been implemented to control the transmission of COVID-19 include: 1) Fewer staff working physically in the office – employees are encouraged to work remotely when possible; 2) Workstations have been modified to maintain six feet between workers; 3) High touch surfaces are disinfected regularly; 4) Steril-Aire UVC lights were installed in the office's HVAC system; 5) In-person meetings are cancelled until further notice – monthly membership meetings are held via ZOOM. Please contact the office to register (you must be in good standing and have a valid email address).

Anyone who feels sick or has been around someone that is sick should stay home to prevent spreading germs in the office. Maximize the use of telecommunication, including paying by check or credit card over the phone, signing the out-of-work list, scheduling training classes, getting DPR's, and filing for unemployment.

While most transactions can be done from home, sometimes there is need to come to the office. Some key changes include: 1) Upon arrival, call (808) 941-0991, option 0, to let us know you are here. We will ask COVID-19 screening questions. Please answer them honestly and completely to ensure we can provide you service; 2) If you are cleared for entry, you will be directed to the inside garage entrance (gray double door) to ring the doorbell so a staff member can take your temperature with a touchless thermometer; 3) Face masks are required for entry; Please don't bring guests – we are trying to limit the number of people in the office.

Thank you for your understanding as we navigate through this evolving situation and comply with government directives. Take care and don't hesitate to reach out with any questions.

Even though our Spring semester graduation was a little different, the district council still managed to provide each of our eight-semester perfect attendance apprentices with a well-deserved gift.

On August 15, the Fall semester officially started. The Training Department and University have made several changes to ensure that apprentices, instructors, and community stay COVID-19 free. One big change has been making the adjustment for training and classes and school lessons online or via ZOOM to reduce our school attendance as COVID-19 numbers keep rising. We all need to do our part to stay COVID-19 free, so please wear your safety glasses and face mask.

Neighbor Island Apprenticeship Classes

District Council 50 is proud to announce the start of apprenticeship classes on the islands of Maui, Kauai, and Hawaii. With the establishment of apprenticeship classes on the other University of Hawaii Community College campuses, District Council 50 will be able to provide more related hands-on instruction to its apprentices.

Along with face-to-face classes now available, we are also able to provide our members with distant learning capabilities. In addition to the Learning Management System (LMS), we are also capable of providing virtual classroom environments using ZOOM. With ZOOM, we are able to bring classes together from separate locations at the same time and also utilize instructors who do not reside on a particular island. In this day and age, having the ability to login using an electronic device to receive the best possible training is definitely an added advantage to our members and our industry.

This is only the beginning of the neighbor island classes, and we feel very confident that things will only improve as we move forward. Remember: District Council 50's main concern is the health and safety of our entire membership!

Glaziers Report

Although there were a few cases of COVID-19 reported on some of the jobsites, none of the sites were shut down for more than a few days. To date, none of our members has contracted the coronavirus from these work sites. We are continually monitoring the safety procedures in place at the jobsites with jobsite visits.

The Glaziers are really busy and we are so short-handed that we are trying to recruit journeypersons from the Mainland. Projects that are current to 2021 and beyond are The A'ali'i, the Daniel K. Inouye Mauka Expansion Airport Project, Imperial Plaza Skylight Replacement Project, the Queen Emma Building Renovation Project, Azure Ala Moana, The Central Ala Moana, The Lilia Waikiki, and the Ko'ula Project.



The start of many projects depend on ending the COVID-19 pandemic, such as 1500 Kapiolani, Ka Haku by Hilton Grand Vacations, Ililani in Kaka'ako, and the Hilton's Homewood Suites at the Daniel K. Inouye International Airport.
