

**NOTICE OF THE INTERNATIONAL UNION OF PAINTERS  
AND ALLIED TRADES  
2025-2028 PER CAPITA TAX AND ADMINISTRATIVE DUES INCREASE**

**Changes to IUPAT Dues Structure**

At the International Union of Painter and Allied Trades (IUPAT) 33rd General Convention in August, a significant decision was made to alter our current dues structure. The IUPAT Laws and Constitution Committee, along with delegates from local unions across the United States and Canada, voted to adopt this new structure, which all District Councils are required to follow. Below are the key details regarding these changes.

**Per Capita Tax (PCT)**

Under Section 17 of the IUPAT Constitution, the per capita tax (PCT) for the period from January 1, 2025, to December 31, 2027, will remain at **\$33.10 per month**, with a **\$2.00 death benefit payment**. Starting January 1, 2028, through December 31, 2029, the PCT will be decreased to **\$6.00 per month**, while the death benefit payment will remain the same.

**IUPAT Administrative Dues**

Each member is required to pay IUPAT Administrative Dues based on the hours they work. Under the new structure, IUPAT Administrative Dues will increase starting January 1, 2025, through December 31, 2029. The scheduled increase is as follows:

- **Effective January 1, 2025:** \$0.25 for every hour worked.
- **Effective January 1, 2026:** \$0.35 for every hour worked.
- **Effective January 1, 2027:** \$0.45 for every hour worked.
- **Effective January 1, 2028:** \$0.55 for every hour worked.

**District Council 50 (DC50) Contribution to IUPAT Administrative Dues**

Since June 1, 2022, District Council 50 has contributed IUPAT Administrative Dues on behalf of working members \$0.10 for every hour worked. DC50 will continue to contribute \$0.10 for every hour worked through 2029.

The breakdown of IUPAT Administrative Dues payments from 2020 to 2029, reflecting DC50's contribution and the scheduled increases, is as follows:

**Purpose of PTC and IUPAT Administrative Dues**

Again, the scheduled changes are mandatory for all District Councils of the IUPAT. Both the PCT and the IUPAT Administrative Dues are paid directly to the IUPAT, **not to DC50**. These funds are crucial for supporting the IUPAT's national and international operations, initiatives, and benefits provided to its members.
