Sadly, this measure was not taken up in the U.S. Senate and failed to pass. This year, the measure was reintroduced and has the support of President Biden; we remain hopeful that it will be ratified and become law in the upcoming months. Ko'ula at Ward Village

oʻula is the Howard Hughes Corporation's sixth mixed-use project at Ward Village. Located at 1000 Auahi Street, just makai of The A'ali'i, this project has created more much-needed work for our District Council 50 Glaziers, Caulkers, Painters, Tapers and Floorlayers, with work extending into next year. The general contractor on this project is Hawaiian Dredging. Our subcontractors on this project include Kalu Glass, Caulking Hawaii, Jayco, WE Painting, BEK, BMK, and Honolulu Premier Flooring.

Koʻula means red sugarcane in Hawaiian, which is why the exterior of the building is designed to mimic the sway of red sugarcane. Another unique feature is the lobby, which is located on the second floor.

The COVID-19 pandemic has not slowed down work for us at all. In fact, we are busier than we have ever been in recent years. Other ongoing and upcoming work includes the A'ali'i at Ward Village, C2F, The Central Ala Moana, The Lilia Waikiki, The Block, Puhulani Elderly, Victoria Place, The Park on Ward (Block H), Ulana Ward Village (Block F), 902 Alder Street, Kokua Elderly House, Halewai'olu Senior Residence, Sky Ala Moana, Mandarin Oriental Waikiki, 1500 Kapiolani, and others.

Political Department Report

In the 2020 General Election, Hawaii's new mailin voting process once again proceeded smoothly and without significant controversy, just as it did in the Primary Election. District Council 50's Political Department and your local unions worked hard to support candidates locally and nationally that will support our union. We were successful in many races locally, and we are now working with those elected officials to protect the rights of our members and working men and women across the state. As this goes to press, we are approaching the halfway point in the 2021 Session, and, so far, we have been successful in protecting our trades and ensuring that construction work continues uninterrupted.

With your help, we were also able to elect President Joseph Biden, who has pledged to support unions and the working class. We also worked hard to flip control of the U.S. Senate so that both chambers of Congress are now controlled by Democrats. We expect that this change will mean a federal government that no longer actively works against unions like ours, but instead works with us. We are currently working with our International Union to have a bill passed in Congress that will strengthen unions, ensure better benefits for their members, and empower working people.

Over the years, we have constantly been stressing to you the importance of voting for politicians who support us. Your support and your votes this election cycle demonstrated the power of your vote and has enabled us to make significant political gains that will help us reverse the tide of anti-union thought and action. Rest assured that your Political Department will be working hard to ensure that the politicians we endorsed follow through with their commitments to support us in our efforts to strengthen and improve our trades.

Drywall: Exceeding the Limits

Stilts go back as far as the 6th Century and have been used for many different purposes, from entertainment to construction. In recent years, the use of stilts has increased by at least 200 percent – mainly due to construction workers like drywall finishers, hangers and plasterers, as well as painters.

Stilts were introduced to the drywall field in the early '60s by

wasn't until the '90s that the Tapers Union introduced them in its apprenticeship classes. Still, many contractors viewed them as a safety issue. The potential for injury was mainly due to poor house-keeping on the job site, including construction debris, extension cords, pipes, voids in the floor, and other safety factors.

In the latter part of the 1980s, there was a Proposed Rulemaking

as Safety Standard developed by the OSHA for the use of stilts, classified in the same category as scaffolds. Still, usage remained limited. It was not until sometime after 2002 that stilts were put into the OSHA Standards and its use was allowed on construction sites under certain conditions. Ever since then, its popularity has grown, as more younger apprentices and journeymen started to use them and considered them as a necessary part of their personal tools.

With the increased demand, construction supply houses have begun to sell them and the cost of a pair of stilts has risen. On the mainland, they are also using them consistently. At the Drywall Trade show there are many vendors with various brands of stilts. Stilts are an integral part of construction technology, following the introduction of drones, power tools, cordless tools, and better heavy equipment. Why we even

have robots scurrying around job sites doing take offs and reporting on daily progress. Will it ever end?

It was a splatter finish on the ceilings and walls, and it took the apprentices two Saturdays to do most of the taping. Instructors Glen Frigillana, Linda Espinoza, and Alex Magnuson donated extra time to complete the house. Habitat for Humanity provided instructors and apprentices with lunch, snacks and lots of soft drinks to show their appreciation.

Turtle Bay Resort

ATTENTION GLAZIERS!

Architectural Glass and Metal Technician (AGMT) Certification

istrict Council 50 Training Department is currently accepting applications for qualified Glaziers interested in becoming a certified Architectural Glass and Metal Technician. Currently there are over 300 certified technicians within the entire IUPAT organization. This certification is already being written into the project specifications as a requirement and it'll only be a matter of time that we will be seeing it more commonly added. With that in mind, the IUPAT, District Council 50, and the rest of the District Councils, are working hard to get our Glaziers through our written and practical exam prep classes.

Becoming a certified technician requires passing a Knowledge Based Test (KBT) as well as a Performance Base Test (PBT) normally done at the same time in person with a proctor. With the current situation of COVID-19 at hand, the Knowledge Based Test (KBT) is now being offered as an online exam.

The Practical Based Test (PBT) is currently postponed till further notice but will resume as soon as it is safe.

Prerequisites. In order to qualify and apply for the AGMT exam, there are a couple requirements an applicant must have, such as an OSHA 10 certification and proof of 7,500 hours of glazing experience over five years.

New Health Requirements

There are new health requirements for all University of Hawaii campuses. To comply with the Department of Health requirements for post-secondary instruction, effective Spring 2021, all students who will be enrolled at Honolulu and Hawaii Community College must meet special health requirements before being registered. Students need to submit a TB clearance and a record of specific immunizations. Students will not be able to attend classes until they are cleared by the records office. CAS Certification

From December 5-12, 2020, the District Council 50 Apprenticeship and Training Department administered a CAS Level I and II certification for our members at Honolulu Community College.

FTI Apprenticeship Training Representative Ken Seal was able to proctor the testing. Apprentices in PD-5 and PD-6 were able to be tested in CAS Level I, while eight journeymen participated in the Level II certification.

After a successful CAS certification week on December 23, the
